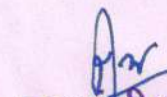
NOW THIS TRUST DEED WITNESSETH AS FOLLOWS:

01. That the name of the Trust shall be **JVBI Alumni Association**.
02. That the registered office of the Trust shall be situated at **Jain Vishwa Bharati Institute (Deemed University), Ladnun, Rajasthan India**, or at such other place or places as the Board of Trustees may decide from time to time. Branch / administrative offices / Chapters can be opened in any part of the country for the smooth functioning of the Trust.
03. The Board of Trustees shall hold a sum of Rupees 1,000.00 (Rupees One Thousand Only), this day paid to them by the Settler and all money, funds, other movable or immovable properties and incomes thereof which may hereinafter be received by the Board of Trustees from time to time as Gifts, Donations, Grants, Subscriptions or otherwise for the purposes of the Trust and the Trust fund shall vest in the Trustees jointly.
04. That **JVBI Alumni Association** shall be committed to create and maintain a life-long connection between the Jain Vishwa Bharati Institute and its alumni. It shall work to connect alumni, support students and build an unforgettable Institutional experience through a diversity of events, programmes and services.
05. That **Vision of JVBI Alumni Association** shall be to **engage the global alumni community of Jain Vishwa Bharati Institute (Deemed University) to support and advance the University's excellence**.
06. That the **Mission of JVBI Alumni Association** (the Jain Vishwa Bharati Institute Alumni Association) shall be to foster a lifelong spirit of belonging and pride by connecting alumni, students, and friends to the Magadh University and each other and also to advocate for the University and its alumni with a credible, independent, and collaborative voice.
07. That the **JVBI Alumni Association**; the Jain Vishwa Bharati Institute (Deemed University) Alumni Association shall be committed to excellence in all its activities and shall be dedicated to the following core values:
 - Loyalty – Pride in and commitment to the future that we are creating together as a Institute and an alumni community, while honoring our history, traditions and achievements.



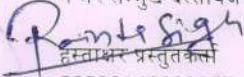

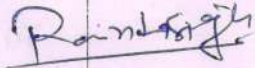


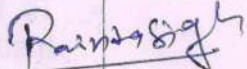

- To aid or establish any institution technical or otherwise to promote education of Art, Social Science, Technology, Management, Legal Studies, Social Sciences, Humanities or other fields of knowledge for the benefit of people at large.
 - To arrange and provide medical aid and other assistance necessary for living to the needy people who are incapable or handicapped or mentally/physically retarded and financially deprived.
 - To issue appeals raise funds and accept gifts, donation subscriptions in cash or in kind and any property either movable or immovable for the achievement of the objective of the trust.
 - To acquire, purchase or otherwise own or undertake on loan or lease or hire temporality or permanently and movable or immovable property necessary or convenient for the furtherance of the objectives of the trust.
09. That all the incomes, earnings, movable / immovable properties of the trust shall be solely utilized and applied towards the promotion of its aims and objectives only as set forth in the Memorandum of the trust and no profit, thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any other manner whatsoever to the present or past members of the trust or to any person claiming through anyone or more of the present or the past members.
10. That no member of the trust shall have any personal claim on any moveable or immovable properties of the trust or make any profits, whatsoever, by virtue of this membership.
11. That activities shall be organized generally to do in all public including the JVBI Alumni for charitable purposes and for public benefit without any discrimination of Caste, Creed, Color, Gender, Religion, Faith, Race or any Nationality. That in case any of the objectives of the Trust are held to be non- charitable within the meaning of section 2 (15) of the Indian Trust Act, or any statutory modification (s) thereof, the Trustees shall not carry out such objectives.
12. **THE BOARD OF TRUSTEES SHALL HAVE THE FOLLOWING POWERS:**
- 12.1 To manage the properties, assets and funds of the Trust, from time to time, frame such regulations (not being inconsistent with this deed) as they may think fit for and necessary for the purposes of such management and control or in connection with the execution of any of the subject herein contained or powers hereby vested in them and may rescind or alter any such regulation.
- 12.2 To accept donations, contributions, grants, subscription in cash or in kind from any person, company, firm, association, organizations, government, non-government or semi-government agencies, national or foreign funding agencies, family Trust(s), or corporate bodies for furtherance and achievement of the objectives of the Trust.
- 12.3 To appoint a managing Trustee, when necessary.
- 12.4 To appoint officers and members of staff for the Trust and to prescribe their condition of service.
- 12.5 To open and to provide for operating banking accounts.
- 12.6 To raise loans with or without security or to invite donation and financial help.
- 12.7 To receive the honorarium or salary against his/her services or involvement in any of the project or programme run by the Trust, which must be decided and approved by the Board of Trustees.
- 12.8 To authorize person (s) to sign or execute documents on behalf of the Trust.

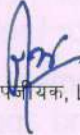

- 12.9 To grant receipts for aid or donation received.
- 12.10 To grant Special Power of Attorney to represent the Trustees in connection with any legal or other proceedings.
- 12.11 To acquire land or building on the lease or way of purchase.
- 12.12 To compromise, compound or refer to Arbitration all actions, proceedings and disputes relating to Trust property or properties.
- 12.13 To sell or give on rent/lease or on hire any immovable or moveable property of the Trust for some certain period(s) on such terms and conditions as the Trustees may think fit and proper from time to time.
- 12.14 To open any type of bank account(s) whether saving account, current account, fixed or otherwise, in the name of the Trust or institution(s) or programme(s) run by the Trust with any scheduled banks or post offices and to operate by the authorized signatory or signatories as Board of Trustees think fit and proper to authorize any person or persons, unless and until determined otherwise the such bank account(s) shall be opened and operated jointly with signatures of any two members of Board of Trustees; to be decided by the Trustees.
- 12.15 The financial year for the Trust shall be from 1st April to 31st March and the accounts of Trust or institution(s) or programme(s) run by the Trust shall be audited yearly by the chartered accountant or a firm of chartered accountants to be appointed by the Board of Trustees and the fee for auditor(s), if paid, shall be a part of outgoing amounts from the Trust Funds.
- 12.16 To give guarantee of the assets and property of the Trust, including the bank guarantee on behalf of the Trust to corporate bodies, persons, firms, institutions, as Trustees may decide from time to time. The Trustees shall not be personally liable for such guarantees or the securities.
- 12.17 To appoint lawyer, pleaders, advocates to file and defend suit or suits filed for and against the Trust and or in the name of the Trust and also file suits for financial and other disputes or dues with different parties and signed executed such application, petition documents for such proceedings and delegate powers to the officers(s), employee(s), staff(s) and Trustee(s) for such proceedings(s) as required from time to time.
- 12.18 To appoint new member or members of Board of Trustees by a resolution and to discharge any of the Trustee, who become bankrupt or acts in any manner prejudicial to the interest or objects of the Trust or is convicted of a criminal offence involving moral turpitude or becomes of unsound mind or is otherwise unfit to continue as Trustee, by a resolution passed by simple majority of members present and voting in the meeting of Board of Trustees.
- 12.19 To appoint from time to time on such terms and conditions as they may determine a Manager, Executive Director, Director(s) and other officer(s) or members(s) of staff for carrying out the activities of the Trust and to remove at any time any such Manager, Executive Director, Director(s) and other officer(s) or members(s) of staff.
- 12.20 To retain the income from the Trust to the tune of ten percent (10%) of the balance of the income in a reserve fund to be utilized when, in the opinion of the Board of Trustees, there is any emergency and the remaining income may be utilized for the purpose of the Trust after defraying all necessary

expenses incurred. However, the principle and proportion could be reviewed from time-to-time by the Trustees.

- 12.21 To invest the Trust fund in government securities, saving certificates, fixed deposits or in any other form of investment authorized under provisions of INDIAN TRUST ACT and INDIAN INCOME TAX ACT, 1961, as Trustees shall deem expedient.
- 12.22 It has further been decided that as and when the Trust is enclosed or dissolved all the funds of the Trust shall be transferred to the other recognized Public Charitable Trust having similar objectives.
- 12.23 All questions relating to the management of the Trust or the exercise of the powers vested in the Trust shall be decided at a meeting or, if necessary and expedient, by circulation. Every such question shall be decided by a majority of the Trustees present and voting in any meeting of Board of Trustees or by the circulation, as the case may be and any action or decision of such majority shall be as valid as if it was done or made by the all Trustees.
- 12.24 In case of occurrence of any vacancy amongst the Trustees because of death, resignation or incapacity of any Trustee or any other cause, a new Trustee may be appointed to fill the Vacancy.
13. The number of Trustees shall not be less than Four and not more than Eleven persons. The Board of Trustees shall nominate and invite person/persons to be the other trustees for such period, as they may deem fit and proper. The tenure of Trustees shall be decided by the Board of Trustees.
14. All matters not provided for in this Trust deed but necessary for the administration of the Trust or for giving effect to the objectives of the Trust may by resolution(s) made by the Board of Trustees shall be carried by a special majority of two third of total number of the Trustees.
15. **GOVERNANCE OF THE TRUST**

(A) Patron: The Patron shall be ex-officio; the Vice Chancellor of the JVBI.

(B) President :

There shall be a Chairperson for the administration of this trust, nominated by the Board of Trustees, who shall be one amongst trustees for such period, in a manner as may be specified by the Board of Trustees.

(C) In addition there would be positions of **Vice President(s), Secretary, Joint Secretaries and Treasurer**, which would also be nominated by the Board of Trustees.

(D) VACANCIES:

Any vacancy among the Members of the Board of Trustees may be filled by the Trustees as specified above or their successors and they shall hold office for such duration as may be specified by the Board of Trustees.

(E) TERMINATION OF OFFICE OF THE TRUSTEES:

(a) Trustee shall cease to hold office:

- i) if s/he dies,
- ii) if s/he resigns,
- iii) if s/he is adjudged insolvent or found guilty of an offence involving moral turpitude.

- iv) if s/he is found to have acted against the interest of the Trust.
- v) if it is unanimously decided by the Trustees that his/her continuation in the Office is against the interest of the Trust.
- vi) Upon expiry of the period up to which the Board of trustees have nominated the trustee.

(F) MEETING AND PROCEEDINGS OF THE TRUSTEES:

The Trustees shall ordinarily meet once in three months or as often as may be necessary for the satisfactory conduct of the affairs of the Trust or as decided by the Chairperson.

a. NOTICE:

Seven days Notice shall ordinarily be given in writing for a meeting of Board of Trustees, which would be issued under the signature of the Chairperson.

b. QUORUM:

The Quorum for the Meeting of the Board of Trustees shall be fifty percent of the total number of trustees present. In case the required quorum is not met with, a meeting of the Trustees shall be convened after half an hour of the scheduled meeting. A minute book shall be kept by the Secretary. Minutes of entry into the office of every new trustee and of all proceedings of the meeting of the Board of trustee shall be entered in the minute book and shall be signed by the Chairperson of the Meeting.

c. TRANSACTION OF BUSINES AND VOTING:

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. The important matters would be decided at the meeting as per decision of the Chairperson. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The Chairperson of the Board of Trustees shall have a casting vote in the event of equality of votes, in addition to his/her own.

d. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

(a) All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objectives of the Trust.

(b) In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, duties and functions:

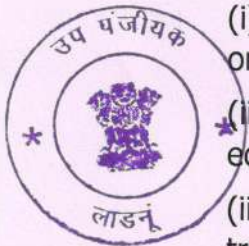
(i) To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable Property.

(ii) To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.

(iii) To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust.

(iv) (a) To raise loans, to receive monies, securities or other movable property on behalf of the Trust.

(b) To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of this Trust.

- (v) To award scholarship and make donations calculated to promote the objects of the Trust.
- (vi) (a) To enter into contracts, or engagements on behalf of the Trust.
- (b) To consider such proposals submitted by Sub-committee appointed by this Trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.
- (vii) To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.
- (viii) To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.
- (ix) To sell, transfer or otherwise dispose of any immovable property of the trust provided all the trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust.
- (x) To appoint Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.
- (xi) To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.
- (xii) To delegate to the Managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees.
- (xiii) To frame Bye-Laws and such other regulations as are required for achieving its objectives.
- (xiv) Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely:
- (a) All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part thereof.
- (b) The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
- (c) The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
- (d) The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
- (e) Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this trust.
- (f) Cost and expenses of keeping the trust property in good condition.
- (g) Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.

- (h) The architect's fee and legal charges and fee payable to other professionals engaged in the course of administration of the trust.
- (i) All other costs, charges and expenses of and incidental to the management and administration of the trust activities and property in accordance with the objects and purposes hereof or which may be incidental thereto. After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees.

e. BOOK OF ACCOUNTS:

- (i) The Board of Trustees may open such Bank Account or Accounts in any of the Banks in the name of **JVBI Alumni Association**. Such accounts shall be jointly operated by the Chairperson and other signatory, as decided by the Board of Trustees and duly approved by the Chairperson.
- (ii) The trust may open Bank Account/s in the name of institution/organisation founded by the Trust. Such Bank Accounts shall be operated by such persons as authorised by the Board of Trustees from time to time.
- (iii) The income and expenditure account shall be separately maintained under the supervision of the Chairperson.

f. RESIDUARY:

For matters not provided for in these presents, the provisions of the Indian Trust Act and the Income Tax Act, 1961 and rules made there under will apply accordingly.

g. JVBI Alumni Association; the said Trust shall be and remain irrevocable for all times, and the settlor doth hereby also release, relinquish, disclaim, surrender and determine all his/her rights, titles, interest or powers in the trust fund.

h. MEMBERSHIP:

- **Honourable Life Membership** shall be open to any person of eminence who has rendered distinguished service to the Association and the Institute, on the recommendation of the Executive Committee. A motion to confer Honorary membership must be made and approved at a General Meeting.
- **Overseas Membership** shall be open to all Alumni residing outside India upon payment of the Entrance Fee payable by an Overseas Member and the approval of the membership application by the Executive Committee.
- **Ordinary Membership** shall be open to all Alumni and present and former members of the Institute Council upon payment of the Entrance Fee payable by an Ordinary Member and the approval of the membership application by the Executive Committee.
- **Life Membership** shall be open to all persons entitled to become an Ordinary Member residing in India upon payment of the Entrance Fee payable by a Life Member and the approval of the membership application by the Executive Committee.



I. Members' Rights and Obligations

- ❖ Members shall have the obligation to observe the provisions of the Trust Deed and to abide by the decision of the Executive Committee and General Meeting insofar as the affairs of the Association are concerned.

- ❖ The Voting Members shall have the right to elect the Executive Committee and to hold office, attend and vote at any meetings of the Association which they are entitled to attend.
- ❖ All Membership Subscriptions and Entrance Fees once paid shall not be refundable.
- ❖ If any Member shall fail to pay his Membership Subscription(s) or such other sums which may be due from time to time to the **JVBI Alumni Association**; the Association for a period of 2 months after the same has become due, a written notice may be sent to him calling his attention thereto, and if he does not pay the outstanding amount within 14 days from the giving of such notice, his name may be removed by the Executive Committee from the books, whereupon he shall cease to be a Member.

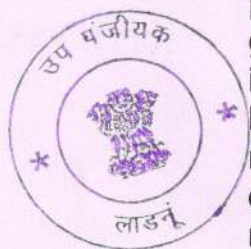
J. General Meeting

- ✚ The First General Meeting shall be held at such time, not being less than one month nor more than three months after the incorporation of the Association and at such place, as the Executive Committee may determine.
- ✚ An Annual General Meeting shall be held once in every calendar year at such time (not being more than fifteen months after the holding of the First General Meeting) and place as may be prescribed and convened by the Executive Committee.
- ✚ All General Meetings other than Annual General Meeting shall be called Extraordinary General Meetings.
- ✚ The Executive Committee may, whenever they think fit, convene an Extraordinary General Meeting, and Extraordinary General Meeting shall also be convened on such requisition or in default may be convened by such requisitionists, as provided in the by-laws of the JVBI Alumni Association; the Association of Alumni by the Board of Trustees.

K. Notice of General Meetings

- An Annual General Meeting and a meeting called for passing of a special resolution shall be called by at least 21 days' written notice (exclusive of the day on which the notice is served or deemed to be served, but inclusive of the day for which notice is given), and any other General Meeting shall be called by at least 14 days' written notice, and the notice shall be exclusive both of the day upon which it is served or deemed to be served and of the day for which it is given. A notice shall specify the place, the day, and the hour of the meeting and, in case of special business, the general nature of that business shall be given in manner hereinafter mentioned, or in such other manner, if any, as may be prescribed by the Association in General Meeting, to such persons as are, under the regulations of the Association entitled to receive such notices from the Association, but, with the consent of all the Members entitled to receive notice of the meeting that may be convened by such shorter notice and in such manner as those Members may think fit.
- The accidental omission to give notice of a meeting to, or the non-receipt of notice of a meeting by, any person entitled to receive such notice shall not invalidate the proceedings at the meeting.
- Rules of Business shall be framed by the Board of Trustees.

- L. Powers and Functions of Office bearers shall be decided by the Board of Trustees and accordingly such rules would be framed and brought on the record.
