

Samani sPratibha Pragma representing Institute of Jainology at the 50th anniversary of Nostra Aetate at the Vatican

Between 26 to 28 October 2015, Vatican celebrated the 50th anniversary of **Nostra Aetate** (In our time) which is a Vatican Council document that for the first time in the history of the Church paves the way for the Catholic Church's official dialogue with the followers of other religious traditions. To commemorate this historical day, a three day international inter-religious conference was organized by Pontifical Council in collaboration with the Gregorian University in Rome. The conference deliberated on 'Believers at the service of humanity' with sub-themes such as violence, religious freedom, education of values etc. The **Institute of Jainology UK** received a recommendation from ONE JAIN organisations for a scholar to represent Jainism.



Samani Pratibha Pragma accepted to be the Jain representative and presented a paper on “**Education and the transmission of Values: A Jain perspective**”.



During the inaugural session **Samani Pranav Pragma** recited the auspicious Jain Prayer of Namaskar Mahamantra and Mangal Path in Prakrit language.

Samani Pratibha Pragmaji conveyed greetings on behalf of the entire Jain community of approximately six million Jains around the world. She expressed her heartfelt gratitude for the invitation extended by the Pontifical Council for Interreligious Dialogue to attend this conference organized on the occasion of the 50th anniversary of Nostra Aetate. She emphasised that may the historic celebrations of the 50th year of Nostra Aetate reaffirm our conviction on the necessity of interreligious dialogue particularly in today’s testing times and may it further strengthen our resolve to promote peace and harmony in our society.

Pope Francis marked the 50th anniversary by outlining the turning point in the Catholic Church's relations with Jews and people of other faiths by calling for greater interfaith collaboration in the face of religious extremism. He devoted his usual Wednesday general audience to explaining to the Catholic faithful in St. Peter's Square the importance of "Nostra Aetate," or "In Our Time" declaration, which revolutionized the church's relations in particular with Jews. The statement was one of the most important documents to emerge from the Second Vatican Council, the 1962-65 meetings that brought the church into the modern world. It said Christ's death could not be attributed to Jews as a whole, recognized the shared spiritual patrimony between Christians and Jews and decried all forms of anti-Semitism.

Jains, Jews, Muslims, Hindus and Buddhists were in the VIP seats in the piazza and were treated to a meet-and-greet session with the pope after the general audience ended. **When**



H. H Pope Francis approached the Jain nuns, Samani Pratibha Pragma and Pranav Pragma, he raised his hand to shake hands, but in response Samanijis folded their hands in Namskar pose. H. H. Pope did the same and asked O sister pray for me. Samani Pratibha Pragma responded, "Father you pray for the world!" Pope humbly replied "that's why I need your prayers for me". Samani Pratibha Pragma, said she was moved by the Pope's humility when he asked her to pray for him. She also described the interreligious meeting as a garden with a collection of different flowers that displays "the beauty of mankind."

Father Santiago took care of Jain group for their rules and regulation. Samaniji got opportunity to discuss about Jain faith with Rev. Father Turan. Rev. Fr. Miguel Angel Ayuso Guixot, MCCJ, Secretary of the Pontifical Council for Interreligious Dialogue supported during the three days stay at Vatican.


During their stay at our Center at Iselin, Samaniji initiated and conducted various spiritual and educational activities as noted below
