Cooperation Agreement

between

Jain Vishva Bharati Institute (JVBI), Ladnun

and

**Ghent University
Faculty of Arts and Philosophy**

In accordance with a mutual desire to promote international academic, cultural and scientific exchange, Ghent University, Faculty of Arts and Philosophy (Belgium) and Jain Vishva Bharati Institute, Ladnun (India) enter into this Cooperation Agreement.

Both institutions, for the purpose of furthering cooperation through both educational and academic exchanges, hereby affirm their intent to promote such exchanges as will be of mutual benefit for their institutions. Educational and academic exchanges are considered here to include but not be limited to:

- Development of mutually beneficial academic programmes and courses;
- Exchange of academic staff and research assistants for the purpose of teaching and research;
- Exchange of students for study and research;
- Reciprocal assistance for visiting academic staff and students;
- Exchange of documentation, pedagogical information and research materials.

Both parties decide by mutual consent that all the financial agreements will have to be negotiated and will depend on the availability of funds.

A. Student exchange

Both parties hereby agree that:

1. Ghent University may in principle nominate up to 15 undergraduate and 2 graduate students for exchange each year. JVBI can nominate up to 3 students for exchange each year. While nominees will normally be accepted for exchange by the host university, the host university reserves the right to review the applications of nominees and make final decisions concerning admission.
2. A selected student may study for a period of 1 to 12 months at the host university. Exchange students will not pay examination, matriculation and tuition fees to the host university, but shall pay these to the home institution as per the usual regulations of the home institution. Ghent University students will have to pay a programme cost to JVBI covering accommodation, meals, internet usage, local transport and registration.
3. Any academic credit received during the course of the program at the host institution may be transferred to the home institution in accordance with the appropriate regulations of the home institution.
4. Each host institution will issue appropriate documents for each accepted nominee for the issuance of a student visa, in accordance with current national laws. It is the responsibility of each individual student to obtain a student visa in their home country in a timely manner.
5. The student will provide his or her own health, accident, repatriation and civil liability insurance.

B. Staff exchange

Both parties hereby agree that:

1. Both parties agree to support the exchange during each academic year of maximum 2 professors or members of scientific staff from each university.

- 2. However, this number may vary in any given year provided a balance of exchanges is attained over the term of the agreement.
- 3. Each host institution will issue appropriate documents for each visiting staff member for the issuance of a visa, in accordance with current national laws. It is the responsibility of each individual staff member to obtain a visa in their home country in a timely manner.

C. Scientific research

- 1. Details of each research program or research project shall be arranged by mutual consent by the relevant departments, centres, etc, of both parties subject to the approval of the higher authorities of each party.
- 2. Relevant academic materials, technical information including research reports, periodicals, etc. and other information available to each party shall be exchanged between parties.
- 3. All information and/or data that may be exchanged, acquired and shared in connection with the areas of cooperation between both parties pursuant to this Cooperation Agreement shall be treated strictly confidential and shall not under any circumstances be divulged by the receiving party unless and otherwise such information has already been in public domain.
- 4. Any cost and expenses that may be incurred by jointly performing research programs and research activities shall be negotiated and agreed upon to the satisfaction of both parties before starting such programs and activities.

For Ghent University, Prof Eva De Clercq(Faculty of Arts and Philosophy) will be the responsible academic staff member of the Cooperation Agreement. For Jain Vishva Bharati, Ladnun, this will be Prof Samani Chaitanya Prajna (Comparative Religion and Philosophy, Jainism)

This Cooperation Agreement as well as succeeding plans concerning the concrete proposals of cooperation, shall be effective after approval of the terms of the agreement by the appropriate authorities of the universities. It will remain in effect for a period of 5 years. Thereafter, it will be reviewed and can be amended or renewed as agreed by both parties.

MEMORANDUM OF UNDERSTANDING

JAIN VISHVA BHARATI INSTITUTE (JVBI) and
SWAMI VIVEKANANDA YOGA ANUSANDHANA SAMSTHANA (S-VYASA)
UNIVERSITY

This Memorandum of Understanding ("MOU"), effective as of November 29, 2014 ("Effective Date"), is entered into by and between Jain Vishva Bharati Institute (JVBI), Ladnun, Rajasthan and S-VYASA University, Bangalore, are hereinafter referred to individually as a "Party" and collectively as the "Parties".

Jain Vishva Bharati Institute

1. Jain Vishva Bharati Institute (Deemed University) was established with the inspiration of Gurudev Tulsi. In 1991, Government of India notified JVBU as Deemed-to-be University under Section 3 of University Grants Commission Act, 1956. Gurudev Shri Tulsi remained its first constitutional Anushasta (moral and spiritual guidance) followed by Acharya Shri Mahaprajna as its second Anushasta. Acharya Mahashraman is its present Anushasta.
2. Jain Vishva Bharati Institute is committed to provide the highest quality of educational services to the utmost satisfaction of the students and give them an opportunity to cultivate an integrated personality blended with spirituality and moral values. The institute is located in Ladnun (Nagaur district), Rajasthan. The spiritual ambience of the campus provides a peaceful atmosphere of the traditional "Gurukul", and is ideal for studies and research. The academic environment of the campus fosters self-discipline and promotes quality of life and commitment to higher values.
3. It is only of its kind committed to research in field of Jainism. The practice of pragmatic principles such as anekant, non-violence, tolerance and peaceful co-existence are the noble ideals of this Institute. JVBI continuously strive hard to achieve excellence training, extension and experimentation in various branches of learning compatible to the mission of the Institute.

S-VYASA

4. S-VYASA is a Deemed to be University, since 2002 recognized by the Ministry of Human Resource Development through UGC under section 3 of UGC Act 1956. S-VYASA has been engaged in Higher Education, Research and Clinical Services. It holds around 10% of the world's scientific literature on Yoga and Allied Sciences and has to its credit more than 15 disease specific evidence based Yoga therapy modules including one for Cancer.
5. Whereas, both parties viz. S-VYASA and JVBI through MOU will serve as the basis for a mutually beneficial relationship between the parties for their collaboration in the current context, to promote biomedical and social behavioral sciences using facilities and

expertise at both the places. Therefore, both parties are agreeable to enter into a MOU for working and cooperating with one another and using their respective expertise, knowledge and resources in the advanced research in field of meditation, technology development and exchange through cost-effective means (the "Project").

Article I: Principle of Cooperation

6. S-VYASA Bangalore and JVBI, Ladnun agree to develop their academic links especially in the fields of Science of Living including Yoga, Clinical Psychology, Social Sciences, Biochemistry, Genetics and Statistics under the principles of mutual understanding, common interest and mutually complementary activities.
 - a. To promote individual contacts among scholars, students and personnel of both the institutions.
 - b. To provide opportunities to both students and staff to use to maximum expertise and facilities available in both the organizations through training of students and staff and through exchange of thoughts by brain storming sessions/seminars/workshops and meetings.
 - c. To work jointly for the common research interest at national and international levels. This includes preparation of proposals and their implementation as per the national health priorities.
 - d. To support the exchange of academic, research and training material.
 - e. To share experience and expertise concerning institute administration and management.
 - f. To encourage any other activities that both the institutions agreed to be on mutual benefit.

Article II: Areas of Cooperation

- a. Exchanging information on various aspects of meditation in promotion of health and prevention and treatment of various diseases and to develop guidelines in clinical, academic, and research aspects of these.
- b. Conduct scientific studies on the effect of Meditation, Yoga and other practices on brain and other body systems in the promotion of health, and prevention and management of various diseases (as an adjuvant to conventional medicine).

- c. Master's/Ph. D. students working at JVBI, Ladnun will be allowed to carry out a part of their research work in S-VYASA and vice-versa depending upon requirements.
- d. Scientists of S-VYASA may deliver lectures in areas of their specialization to students of JVBI as Visiting Faculty or vice-versa on days and timings pre-arranged on mutual consent.
- e. Quality assurance programs, including the exchange of clinical data, information regarding calibration of equipment, evolution of health practices management, and establishing benchmarks and best practices.
- f. Data generated through such collaborative research will be published in scientific journals jointly. Outcome of the study in the form of publication will be shared with the guide from the universities as co-author. Co-authorship will be given to Scientists or any faculties who will help in the study.
7. The parties will establish a steering committee for this project, which will serve as the directive body for decisions, implementations, and monitoring activities developed pursuant to this MOU. The Parties will mutually agree on the composition of the steering committee and on the dates and locations of its meetings. The steering committee may conduct discussion regarding the development of formalized programs
8. Each Party will designate an individual who shall serve as the primary contact for all communications regarding this MOU.
9. Each Party will bear its own expenses related to its participation in the steering committee. The funding for the Project's programs, initiatives, and activities will be negotiated by the Parties as needed.
10. Neither Party nor any affiliate thereof shall use or register any form of the other Party's name, symbols, trademarks, or service marks in any advertising, promotional materials, or other medium (including but not limited to the internet, domain names, or Uniform Resource Locator (URL) addresses) or for any other purpose without the prior, written consent of the other Party.
11. This MOU will be effective through November, 2019, and it may be extended for further periods upon written agreement of the Parties.

12. Either Party may terminate this MOU prior to its expiration as follows:
- (a) This MOU may be terminated by mutual written agreement of the Parties.
 - (b) Either Party may terminate this MOU without cause by giving thirty (30) days' prior written notice to the other Party.
 - (c) Either Party may terminate this MOU with cause by giving ten (10) days' prior written notice to the other party.
13. If any Party wishes to translate this MOU into another language, such Party will do so at its sole expense. Any translation of this MOU shall be used for reference purpose only. In the event of any conflict or inconsistency between the English language version of this MOU and any translation of this MOU, the executed English language version shall govern the interpretation and construction hereof.
14. Any dispute, controversy, or claim arising out of or relating to this MOU shall be settled amicably by the Parties pursuant to mutual, good-faith discussion and negotiations.
15. Any notice under this MOU shall be in writing and deemed sufficiently given when delivered via commercial courier service to the other Parties at their addresses set forth below:

Binding Memorandum of Understanding

This Memorandum of Understanding (hereinafter referred to as "MoU") is made on 8th July 2014 at Gurgaon by and between Aspire Human Capital Management Pvt Ltd (hereinafter called "Aspire") having its registered office at 70-39/B, 2nd Floor, Tower A, KLF Complex, Najafgarh Road, Opposite Police Station Moti Nagar, New Delhi- 110015 represented by its authorised signatory Mr. Amit Bhatia and Jain Vishva Bharati Institute, Ladnun, Rajasthan, a deemed university (hereinafter called "Institution") having its office at Ladnun, Rajasthan - 341306.

Aspire and the Institution is hereinafter referred collectively as "Parties" and individually as "Party".

Whereas Aspire is desirous of offering Employability Enhancement services for the Institution in two Phases wherein Phase I includes (i) an Awareness Seminar including a Motivational lecture, (ii) a Faculty Development Program, and, (iii) NEST Assessments, and Phase II includes Profire and EnglishPro Training at the Institute.

AND WHEREAS Institution is desirous of accepting Aspire's services for enhancing student and faculty capabilities.

AND WHEREAS Institution and Aspire agree upon mutually beneficial transaction and desires of expressing the same into writing and hence this MoU.

Both Parties agree to the following terms and conditions:

1. **Term:** This MoU will come into force and effect from 1st July 2014 and shall remain in effect for a period of 1 year, within which Parties shall enter into an agreement based on this MoU. It is clarified that until such an agreement is executed by the Parties, this MoU shall be fully binding on the Parties and the Parties undertake to fully abide by the terms and conditions of this MoU.
2. **Service:** Aspire shall conduct and execute the programs as per Annexure A. This MOU is approval only for Phase I. Based on Student & Faculty Feedback, the Vice Chancellor will, in 3 months subsequent to Phase I, approve Phase 2 through a letter. Pending this letter, this MOU will expire after Phase I.
3. **Fees:** The fee of the programs is specified in Annexure B. The Institute shall pay 50% advance for each program and 50% on completion. All Payments will be made in favour of "Aspire Human Capital Management Private Limited".
4. **Trainer & Visitor Expenses:** Institution shall be responsible for and bear all costs of travelling and lodging of the trainers, Aspire faculty, Guest speakers and other visitors during the programs which will include single bedroom guest rooms with attached toilets/baths and airconditioning during summer months.
5. **Travel Expenses:** Aspire agrees to bear all Travel expenses for arriving in Ladnun, Rajasthan or the closest railway station or bus terminal or airport.

They have a good collection of old manuscripts, artifacts, etc in their library and museum which they are digitizing. They promote research work of old Jain scriptures, teach ancient Indian languages like Sanskrit, Pali and Prakrit.

This MOU aims at reaching mutual understanding on Preservation and Conservation of archival materials, artifacts, articles of Heritage/Historical/Archeological value and archiving, documenting and digitization of old manuscript, conducting research and sharing of academic information and best practices. ASI and JVBI decide to establish formal communicative and cooperative relation and agree on the followings.

- 1) It has been agreed between both the parties that FIRST PARTY will assist the SECOND PARTY through their experts, to set up a department for conservation and preservation of artifacts and manuscripts in this regards, help to set up their museum, and to digitize the manuscripts and to be able to do all other work that maybe required.
- 2) Both parties also agree to promote the following programs.
 - a) Visit of experts including visiting scholars and researchers.
 - b) Academic information and materials sharing wherever possible
 - c) Joint research programs
 - d) Joint training programs
 - e) Jointly sponsored conference or forums
 - f) Other international cooperative and exchange programs agreed by both the parties.
- 3) However, all the expenses required for travelling, accommodating these experts to be provided by the FIRST PARTY at the request of the SECOND PARTY and all the relating expenses will be borne by the SECOND PARTY.
- 4) The implementation of each programs of the MOU shall be negotiated and determined by both the parties from time to time. For issues not stipulated in the MOU, both the parties may sign a supplement agreement after negotiation and agreement.
- 5) The full autonomy of either side shall not be diminished, nor shall any constraints be imposed on carrying out the MOU.
- 6) The MOU shall be in force for one year and be subject to revision, extension or adding attachment by mutual agreement. This MOU may be terminated by either party by the provision of written notice of termination no less than six months prior to the desired termination date to avoid any possible inconvenience to both sides.



WHEREAS:

- (A) Rajasthan Skill and Livelihoods Development Corporation (RSLDC), on behalf of the Government of Rajasthan has initiated Skill Training for unemployed, marginalized youth & women in State of Rajasthan by way of providing financial assistance through Grant-in-aid received from the State Government, to be released as per Regular Skill Training Program (RSTP) - Youth, Guidelines as amended from time to time.
- (B) RSLDC had accordingly invited proposals for providing Skill Training to unemployed, marginalized youth including school dropouts and women and for providing self-employment and livelihood enhancement, as per guidelines.
- (C) The Program shall be known as "Regular Skill Training Program".

ARTICLE 1

PURPOSE OF MoU

- 1.1. This MoU establishes a framework for execution of project between parties under the RSTP Guidelines (as amended from time to time) issued by RSLDC, Government of Rajasthan. It sets out the role and responsibilities of each of the parties for achievement of common objectives of RSTP.
- 1.2. This MoU is being signed in reference to **Sanction Order no. 9694** dated 14-12-15, containing approved Annual Plan for calendar year 2015. Any future Annual Plans approved by RSLDC and any revisions in approved Annual Plans by RSLDC shall be considered to be a part of this MoU. The terms & conditions mentioned in aforesaid sanction order shall also be a part of this MoU.
- 1.3. Both parties hereby affirm that they shall work towards the implementation of the MoU in letter and spirit.

ARTICLE - 2

RESPONSIBILITY OF JAIN VISHVA BHARTI INSTITUTE the PIA

- 2.1 PIA agrees to implement the program, and shall
 - a. Be fully and directly responsible for achieving the physical targets (as per approved 1st year Annual Plan attached with the MoU) in full compliance with the RSTP Guidelines. It includes all responsibilities of quality training, Assessment & Certification (A&C), self employment of youth trained and follow-up.
 - b. Comply with all terms and conditions (as annexed), in addition to the norms as specified under RSTP Guidelines (and any additional requirements arising out of revisions in guidelines, circulars and orders issued from time to time).
 - c. Proactively endeavour to enhance the quality norms across the project value chain.
 - d. Promptly inform all the parties of any changes or any modifications that affects its legal nature and the objectives under this MoU. Such information shall be communicated in writing to all the parties to this MoU within 7 days of such modification.
 - e. Ensure compliance of all conditions mentioned in RSTP Guidelines (as amended from time to time).
 - f. Furnish to RSLDC any and all such information and reports including utilization certificate-program wise as per guidelines and as demanded from time to time.
 - g. Submit to RSLDC the physical and financial progress reports on quarterly basis besides data entry in RSLDC MIS portal.
 - h. Enable RSLDC or their representatives at any time to inspect any and all books and records pertinent to the grant funds and its utilization as well as any and all audit and accountant reports.

Allow and facilitate inspection of PIA's financial Statements and records and visit of the site of the program implementation by representatives of RSLDC, at any time, to verify the proper use of financial assistance.
- i. Maintain records in accordance with appropriate and accepted accounting practices reflecting its operation and utilization of grant.
 - j. Open and maintain a separate bank account preferably for implementing the Program.
 - k. Maintain separate book of accounts for this project for the purpose of auditing.

It is expressly agreed that PIA shall at all times, be responsible and liable for all its obligations under this agreement notwithstanding anything contained in or any other agreement, and no default under agreement shall excuse PIA from its obligations or liability hereunder.

- l. Ensure that the personnel engaged by it in the performance of its obligations under this agreement are at all times properly trained for their respective functions.
- m. Maintain close coordination and liaison with the District RSLDC office and make available all information, data and record whichever is required by it from time to time.
- n. Submit course wise report as per details given in the applicable guidelines and modifications thereafter to the concerned RSLDC district office for checking/auditing. It will also furnish required information in the MIS to RSLDC headquarter as well as district office from time to time.
- o. Ensure gainful livelihoods of trainees. PIA will submit success stories to RSLDC HQ at Jaipur as per applicable guidelines for release of incentive amount. It shall also follow up with trainees for minimum 3 months after completion of the training. PIA will use RSLDC format for tracking the gainful livelihoods of trainees with other relevant details and inform RSLDC accordingly.
- p. PIA shall keep a permanent record of trainees including their names, parents' name, address, contact number. Course, copy of assessment certificate, copy of BPL / SC / ST / OBC / Gram Sabha certificate, photographs, video clip testimonial, gainful employment details, etc. PIA shall provide a soft copy of such record to RSLDC in required format and keep a permanent record as well.
- q. PIA shall ensure that there is no conflict of interest in execution of work under this MoU. Any such situation shall be immediately reported to RSLDC.

RESPONSIBILITY OF RAJASTHAN SKILL AND LIVELIHOODS DEVELOPMENT CORPORATION (RSLDC)

2.2 RSLDC shall be the program sanctioning, supervising and monitoring agency. RSLDC shall

- a. Discharge its responsibilities through facilitation, timely support and timely review of the progress of the project.
- b. Ensure timely fund release for the project to the PIA as per prescribed service standards and operational norms.
- c. Review and accord sanction for Annual Plan submitted by the PIA, as per the RSTP guidelines.
- d. Conduct regular Monitoring of Performance and outputs.
- e. Conduct regular review of quality performance through field visits, quality assurance checks and inspections.
- f. Facilitate information exchange, dissemination, analysis of trends and feedback into management and monitoring of the trainees.
- g. Exercise stewardship role in accordance with the Guidelines (as amended from time to time) and procedures for RSTP (as issued from time to time).
- h. Undertake regular and concurrent monitoring of the project being undertaken by the PIA, through field visits and MIS review and continuously assess the performance of the PIA.

DISCLAIMER

- 3.1 PIA acknowledges that prior to the execution of this agreement, it has, after a complete and careful examination, made an independent evaluation of the Scope of the Program, Specifications and Standards, local conditions, conditions on ground, and all information provided in guideline document of RSLDC and has determined to its satisfaction the accuracy or otherwise thereof and the nature and extent of difficulties, risks and hazards as are likely to arise or may be faced by it in the course of performance of its obligations hereunder and PIA confirms that it shall have no claim whatsoever against RSLDC in this regard.
- 3.2 PIA acknowledges and hereby accepts the risk of inadequacy, mistake or error in or relating to any of the matters set forth in the agreement and hereby acknowledges and agrees that RSLDC shall not be liable for the same in any manner whatsoever to PIA.
- 3.3 The Parties agree that any mistake or error in or relating to any of the matters set forth in Clause 3.1 above shall not vitiate this agreement.
- 3.4 In the event that either Party becomes aware of any mistake or error relating to any of the matters set forth in Clause 3.1 above, that Party shall immediately notify the other Party, specifying the mistake or error.
- 3.5 Except as otherwise provided in this agreement, all risks relating to the Program shall be borne by PIA. RSLDC shall not be liable in any manner for such risks or the consequences thereof. However such liability shall be limited to and shall not exceed in any circumstances the value of work as per approved annual plans.

ARTICLE - 4

DETAILS OF THE PROGRAM

- 4.1 The program envisages implementation of the "Regular Skill Training Programme" for Youth Women, Person with Special Ability and Jail inmates including school dropouts.
PIA will be responsible for arranging required dedicated skill training infrastructure, identification of courses from the approved list of courses having gainful livelihoods potential, the beneficiaries (as per the guidelines), the facilitators / trainers who will be imparting training and monitoring the program, etc.
PIA will conduct the training programs as per course outlines supplied by RSLDC and submit the account as per RSTP guidelines to RSLDC.
PIA will ensure gainful livelihoods of trainees as per guidelines. (as amended from time to time).
- 4.2 **Key Activities of the "JAIN VISHVA BHARTI INSTITUTE"**
 - a. Establishment of fully equipped dedicated skill training/development Centre with required infrastructure for training. Installation of GPRS enabled Biometric machine with RSLDC prescribed software at the training site and also at the hostel site, if the training program is residential one.
 - b. Market Assessment study from time to time to understand the changing trend and identification of course(s), which have gainful livelihoods potential.
 - c. Identification and hiring of qualified trainers/instructors for each course as per qualification mentioned in the guidelines.
 - d. Orientation and Training of trainers on regular intervals.
 - e. Identification of potential beneficiaries (as per the guidelines).
 - f. Organization of aptitude test of trainees.
 - g. Distribution of relevant instructional material/hand outs to all trainees.
 - h. Organization of training leading to expected competencies.



- i. Organization of training in soft skills/entrepreneurship development, wherever prescribed.
- j. Liaison with RSLDC HQ and district office for various purposes spelt out earlier.
- k. Self employment of at-least 50 % trained youth and their tracking for at-least 3 months.
- l. Establishing and empowering the self-employment monitoring cell / alumni associations.
- m. Maintenance and submission of records to facilitate Vidhan Sabha questions, RTI etc., as and when called for by RSLDC.
- n. PIA will maintain confidentiality of data related to the project or arising from the project implementation. For sharing the data with other agencies, PIA shall take prior approval from RSLDC.

ARTICLE - 5

FINANCIAL OUTLAY

The amount would be released as per details given in the RSTP guidelines. The PIA would be responsible for any applicable tax and levies.

The cost structure includes the following inputs:

- a. Market analysis and need identification studies time to time for delivering appropriate training and micro enterprise launching.
- b. Workforce market identification studies, road shows for youth mobilization, identification and selection of eligible beneficiaries for appropriate skill development.
- c. Participation in capacity building training programs for faculty/ program staff/ industry mentors, etc.
- d. Hiring of HR for conducting and managing training.
- e. Equipping the PIA or nearby accommodation or space taken on rent with required infrastructure as per course out line provided by RSLDC.
- f. Arranging raw material in required quantity for every course.
- g. Providing instructional material or handouts to each trainee of the course and for exposure visit or for hands-on training.
- h. Training of youth.
- i. Monitoring industry institute interface - Self employment monitoring Cell and tracking of beneficiaries.
- j. Administrative and operational expenses of the training programs.
- k. Participating in RSLDC launched MIS to facilitate exchange of information among all the parties and maintaining the website of the project.
- l. Assessment and certification
- m. Preparation & sharing of various records, certificates and information as required by RSLDC.

PIA will open a separate dedicated bank account, preferably for the funds released under the program and any interest accrued on the amount deposited in bank for this program will be used for program purpose only subject to the total sanctioned cost not been exceeded. The program implementation period is three years from the date of signing of the MoU. PIA shall implement the program as per approved Annual Plan and instructions issues by RSLDC from time to time.

The validity of this MoU can be extended further for an agreed period with mutual consent of both parties.

ARTICLE - 6

DISBURSEMENT/SHARE PROCEDURES

The training cost will be released in the name of JAIN VISHVA BHARTI INSTITUTE as per details given in the guidelines document.

- 6.1 RSLDC shall disburse the training cost to PIA to a separate bank account, preferably to be maintained for the program purpose and any interest accrued on the amount deposited in the bank will be used for program works only.

- a. Breach by the PIA in complying with the terms and conditions of this agreement including the non utilization of amount for the purpose for which it has been granted and / or diverting the amount for any other purpose or project other than the program requirement with compliance to article - 5.
- b. Extraordinary circumstances which in the opinion of the GoR / RSLDC are likely to preclude or seriously jeopardize the implementation, the operation, or the purpose and the decisions taken by RSLDC are final.
- 6.3 If any of the situation specified in Article 6.2 (a) or (b) has occurred and has not been rectified / remedied to the satisfaction of RSLDC, it may-
- a. In the case specified in Article 6.2 (a) demand the immediate repayment of all disbursed amount to the extent of non-fulfillment/achievement in complying with the terms and conditions of this agreement which may depend on facts and circumstances as the case may be:
- In the case specified in Article 6.2 (b) demand the immediate repayment of such amounts as PIA is unable to prove to have been used for skill training.
 - If PIA fails to organize training for sanctioned number of youth after receipt of training cost from RSLDC, PIA shall refund the training cost received from RSLDC along with interest at the prescribed rate proportionate to the extent training not organized. The first party shall recover the same as per law.
 - In case of gross misconduct/ irregularity/ non-performance, RSLDC may decide to blacklist the PIA for further training programs.
- 6.4 PIA on behalf of RSLDC shall charge registration fees from each candidate @ Rs. 400/- per candidate from General category men and @ Rs. 200/- per candidate from SC/ST/ Women/ Transgender/ Minority/Specially abled. Batch wise registration amount so received/collected will be sent to RSLDC along with details in prescribed format through DD at the earliest. The registration fee could be revised by RSLDC at its sole discretion from time to time.
- 6.5 The eligibility of PIA to execute this program has been decided on the basis of documents submitted & claims made by PIA. If it is found that there is any substantial misinformation / concealment; RSLDC shall be free to initiate penal action & cancel the MoU on its own.

ARTICLE - 7

EFFECT OF INVALID CLAUSES AND AMENDMENTS

- 7.1 If any of the provision of this agreement is invalid, all other provisions shall remain unaffected thereby. Any gap resulting there from shall be filled by a provision consistent with the purpose of this agreement and settled by mutual consultation.
- 7.2 Any of the provisions of this agreement may be amended or modified at any time by mutual consent through exchange of letters, and all such amendments shall be part and parcel of this agreement.
- 7.3 The legal relations established by this agreement between RSLDC and JAIN VISHVA BHARTI INSTITUTE shall terminate with the end of the completion date of the program as declared by the RSLDC/GoR.

TERMINATION

8.2 By the PIA

In all other cases where PIA has failed to deliver or comply with guidelines advance would be recovered and no final payment would be made.

ARTICLE-9

FORCE MAJEURE

Neither party hereto shall be considered in breach hereof or in default if it fails to perform or observe any or all of the terms of this agreement resulting directly or indirectly, such as, but not limited to acts of God, Civil or Military authority, acts of Public Enemy, war, riots explosion, earthquake, flood, storm, lightning strike, etc. In such case either party shall notify the other party of the occurrence of such cause and should as a consequence, the performance under this agreement be prevented for a period longer than six months, then the other party shall have the right to terminate this agreement.

ARTICLE -10

REMOVAL OF DIFFICULTIES

Any matter not covered specifically in this agreement may be settled by mutual discussions and addendum to the agreement in writing thereupon.

ARTICLE-11

DISPUTE RESOLUTION

- a. Any differences or disputes arise between the parties shall in the first instant resolved mutually by the parties.
- b. The matter regarding breach of any clause under this agreement by the Second Party shall be discussed by both the parties and in case any breach has been committed by the Second Party of any of the terms and conditions of this agreement/ proposal/ guidelines, then decisions taken by the First Party in this regard shall be conclusive, final and binding on the Second Party.

Memorandum of Understanding Between National Mission for Manuscripts

And

JAIN VISHVA BHARATI INSTITUTE, LADNUN (Designated by the Mission as Manuscript Conservation Centre)

Name of the Project: Commissioning tasks pertaining to Preservation and Conservation of Manuscripts for National Mission for Manuscripts.

This Memorandum of Understanding (MOU) is made on the First day of April in the year Two Thousand Eighteen between the National Mission for Manuscripts, Indira Gandhi National Centre for the Arts, 11, Mansingh Road, New Delhi - 110001 hereinafter referred to as NMM, which expression, unless repugnant to the context, shall include its successors, agents and assignees of the first part and Jain Vishva Bharati Institute which expression, unless repugnant to the context, shall include its successors, agents and assignees of the other part hereinafter referred to as Jain Vishva Bharati Institute MCC, whereby the NMM and NMM MCC will collaborate on the projects on Conservation of Manuscripts written on various materials (Organic, Inorganic and Composite Materials such as Paper, Cloth, Palm leaves, Birch bark, Sanchi Pat, Papyrus, Parchment, Leather, Vellum, Metal, Ivory, etc.) and related documents including Preventive and Remedial Conservation, Training, Workshop and Awareness Programmes, on Conservation in institutions and private collections.

Scope:

The responsibilities of Jain Vishva Bharati Institute MCC are preservation and conservation of manuscripts related activities such as:-

- Creating a conservation nucleus in their station of Ladnun.....
- Preventive care and Remedial conservation of manuscripts (institutional as well as private collections and at such places where manuscripts are located) in the surrounding areas, giving preference to their own collection.
- Any other responsibility to be taken up through mutual understanding between NMM and the respective MCC and with other MCCs of the state.
- The output of MCCs shall be as follows:
• The MCCs situated in plain areas should conserve at least 300 folios through remedial (curative) conservation along with 3000 folios through preventive conservation in a month. Yearly output of MCCs situated in plain areas should not be less than 3600

folios through remedial (curative) conservation and 36000 folios through preventive conservation.

- Additional staff may be engaged with prior permission of the Director, NMM according to the workload on the MCC but within the maximum limit of the annual grant.

Duration:

The duration of the project is 3 (Three) years commencing from 01-04-2018 up to 31-03-2021. However, NMM reserves the right to extend or discontinue this MOU and MCC status on the same or modified terms and conditions. The monthly report of the project will be submitted to the Director NMM at the end of every month in electronic format or preferably in print format.

Human Resources & Remunerations:

Dr Yogesh Kumar Jain, Assistant Professor, will be the Project Coordinator on Conservation. There will be one conservation team consisting of the following:

- 1. Project Coordinator (MCC):** No new appointment will be made for the Project Coordinator (MCC) but an existing staff, Head of Department / officer of the institution concerned will be made in-charge of the responsibility. The Project Coordinator will be solely responsible for the work undertaken by the MCC. NMM will not deal directly with personnel assigned for such work as survey, documentation, cataloguing, etc. In the event of relinquishing charge by the Project Coordinator new appointment will be made for the same in consultation with NMM. Honorarium to Project Coordinator shall not exceed ₹ 6,000/- per month.
- 2. Conservator:** One Conservator with educational Qualification of Master degree in Art Conservation / Master degree in Fine arts / Master degree Science having chemistry as subject in graduation or in relevant subject to conservation of manuscripts. Training in the Conservation of manuscripts and art objects from a reputed institution of National level with a period not less than six months along with three years' experience of conservation of manuscripts in a museum or any reputed institution can be appointed with monthly remuneration of ₹ 15,000/- as well as with admissible T.A. and D.A. as per the concern state within a ceiling of maximum ₹2,000/- per month.
- 3. Assistant Conservator:** One Assistant Conservator with educational qualification Graduation with Science chemistry / Graduation with Fine Arts or relevant subject to conservation, Training in the Conservation of manuscripts/art objects from a reputed institution of National level with a period not less than six months along with two years' experience of conservation of manuscripts in a museum or any reputed institution can be appointed with monthly remuneration of ₹ 12,000/- per month..

4. **Technical Assistant:** One Technical Assistant with educational qualification of Bachelor degree with Computer Knowledge and six month experience of conservation can be appointed with monthly remuneration of ₹ 8,000/- per month.

Finance:

NMM shall pay up to ₹ 7, 00,000/- (Rupees seven lakhs only) during the financial year. A separate Bank Account, preferably in Canara Bank branch, to be styled as

NMM - Project Coordinator **Jain Vishva Bharati Institute** MCC to be opened and operated jointly by two signatory's vis-à-vis Project Coordinator and any one of the signatories as authorized by the Head of the Institute or as a separate head in the same institution to be operate as per the MCC's requirement.

The project coordinator shall report immediately to the NMM, in case he/she or his/her institution decides to close the MCC or for any other reason the work of the MCC is stopped at his/her institution, failing which the NMM shall charge interest at a rate of 10% p.a. on the un-utilized balance amount pending with the MCC.

The Project Coordinator shall be responsible for the control of expenditure against the funds needed by MCC.

Expenditures of the MCC will cover establishment expenses (New MCCs only), as well as Remunerations & Honorariums of all staff-members, Office Maintenance Expenses, Photography, Stationeries, Printing / Xerox of documents, Phone, Fax and Internet, T.A. and D.A. of staff-members etc.

- For setting up conservation laboratory where such infrastructure is not available (one-time expenditure) applicable in the case of new MCC.
- The newly established MCC can only utilize an amount of maximum ₹ 1, 50,000/- (One Lakh fifty thousand only) towards establishment of laboratory and purchasing of chemical, conservation equipments and materials, Camera, Connection of Telephone and Internet etc. against which no output will be claimed.
- The initial grant to the new MCC shall ₹ 2, 50,000/- but the total amount of grant for the year shall be remain unchanged i.e. Rs. 7 lakh only.
- The MCC can spend ₹ 10,000/- (Ten Thousand only) for the Awareness Programme on Conservation of manuscripts and maximum two such Awareness Programme can be conducted in each year.
- For the contingencies/conveyance expenditure etc. Of the Project Coordinator (not to exceed a maximum of Rs. 3,000 per month)
- Remuneration of the conservation team will be regulated as under:

Remedial Conservation	-	300 folios (in a month with one team)
Preventive conservation	-	3600 folios (i.e 1; 10 ratio)
Conservator	-	17,000/- per month
Asst Conservator	-	12,000/- per month
Technical Asst	-	8,000/-per month.

The proposed target for preventive conservation is 36000 folios and remedial conservation are 3600 folios per year (i.e. 1; 10 ratio) in said fund of is Rs. 7, 00,000/ (Seven lakhs) per year.

Regarding derailment of staff for training etc. The quantum of work may be divided by 30 and the work for the number of days of participation in the training may be regulated accordingly.

For example: One conservator takes part in a workshop for 10 days:

Work for one month	=	300+3000/one team
Work for one day, for a single person	=	(4+38)/ 1P
Work for 10 days	=	(40+380) 10 = 40+380

In case remedial conservation is done for 40 folios and Preventive Conservation is done for 380 folios, the conservator can be paid full remuneration.

Payment Procedure:

The payment will be disbursed in three installments to the concerned MCC:

- The first instalment of Rs. 2.5 lakha (Rupees two lakhs fifty thousand only) will be released on signing of the MoU.
- Second instalment of Rs. 2.5 lakhs (Rupees two lakhs fifty thousand only) will be released on furnishing of GFR-19A, Account statement, Copy of voucher for the expenditure of not less than 80% of the amount released as first instalment and statement of account
- Third instalment of Rs. 2 lakhs (Rupees two lakhs only) will be released on furnishing of Utilization Certificate in form GFR-19A, Account statement, Copy of voucher for the expenditure of not less than 80% of the amount released as second instalment and statement of account
- The payment of remunerations, honorariums, and other experience shall be made through digital mode. The statement of accounts duly supported by receipts, detailed of payment accounts and copy of vouchers, shall be submitted. All payments, except petty payments less then Rs. 2,000/- , must be made through electronic clearing system or by cheque.

Reporting:

Comprehensive monthly report in electronic form or in print form as per the prescribed performs. The report will include such items as details on preventive and remedial conservation of manuscripts in institutions and private collections, as well as on training and awareness campaigns/workshops conducted in the area. In addition a Monthly Report indicating quantum of work done along with certification addressed to NMM from the concerned institution where the conservation work has been carried must be sent.

NMM will have to be given information in advance for organizing Awareness Program by the MCC and a report thereof will be submitted by the MCC.

Terms of Contract:

- i) The output of the project described in the agreement, together with the materials used or unused, purchased by **Jain Vishva Bharati Institute MCC** through utilizing the NMM fund is to be submitted by Project Coordinator to the NMM.
- ii) The non-recurring items shall be entered in the project stock register. NMM will share copyright over the materials and will be fully entitled to use the same.
- iii) NMM will have the right to foreclose the project at any time after recording the reasons. If, however, the project is foreclosed by **Jain Vishva Bharati Institute MCC**, Project Coordinator or the Head of the Institution for whatever reason, which in the opinion of NMM is not justified, the amount of pending advance with interest along with the project assets will be recoverable from **Jain Vishva Bharati Institute MCC**, Project Coordinator and/or the Head of the Institution. The decision of NMM Executive Committee in this matter shall be final and binding.
- iv) At the end of the financial year the MCC will furnish Annual Progress Report complete in all respects along with the Annual Audit Report.
- v) The MOU shall not be altered, varied or modified, nor any of its provision waived otherwise than by writing signed by both the parties hereto.
- vi) In the event of any dispute arising under, in connection with, incidental to, and / or in interpretation of scope of this MOU or relating thereto, the same shall be referred to a Sole Arbitrator appointed by the Director NMM and the decision of the Arbitrator shall be final and conclusive. The provisions of the Arbitration and conciliation Act, and the statutory modifications amendments and / or re-enactment thereof from time to time shall apply to such arbitration. The place of arbitration shall be at Delhi / New Delhi. The language to be used is arbitral proceedings shall be English and the parties shall bear and pay their own costs, charges and expenses of the proceedings for the arbitration.

- vii) The MOU will be subject to review at the time of disbursement of the second installment and the MCC will operate a separate account/head for the purpose of NMM.
- viii) The project would be subject to assessment and review periodically. As regards the money receipts and payments, the same will be governed by Financial Rules of the Central Government.
- ix) Separate guidelines issued by the NMM will form part of this MOU.
- x) The Courts in Delhi / New Delhi shall have the jurisdiction in respect of all matters, disputes or differences arising out of this MOU.
- xi) This MOU, its existence and all information exchanged between the parties under this MOU shall not be disclosed to any person by the MCC. The MCC shall hold in strictest confidence and shall not use or disclose to any third party, and shall take all necessary precautions to secure any confidential information of the other party.
- xii) Except as specifically set forth herein, the rights and obligations hereunder cannot be assigned by MCC to any other party without the prior written consent of NMM.







NSDL DATABASE MANAGEMENT LIMITED (a wholly owned subsidiary of the National Securities Depository Limited), a Company incorporated under the Companies Act, 1956 and having its Registered Office at 4th Floor, Trade World, 'A' Wing, Kamala Mills Compound, Senapati Bapat Marg, Lower Parcel Mumbai - 400 013 (hereinafter referred to as "NDML" which expression shall, unless it be repugnant to the subject or context thereof, shall deem to mean and include its successors and assigns) of the OTHER PART;

Whereas

The first part is desirous of lodging its academic awards which would be the awards listed by the University Grants Commission (UGC) amongst the following categories:

- any certificate or degree or diploma including related mark-sheets, transcript or evaluation reports or provisional certificates, as the case may be, granted by an Academic Institution; this will also include certificate, degree, diploma for skill development;
- all certifications by National Skill Qualification Framework (NSQF) aligned bodies. This would include all training courses/short term and long term certificate courses/any other courses as offered by institutions approved by the Ministry of Skill Development & Entrepreneurship (MSDE) for participating in NAD;
- Mark sheets, certificates issued by the boards;
- Certificates issued by eligibility test conducting bodies.

And the other part, having been authorized as one of the digital depositories in NAD for the purposes of establishment of National Academic Depository (NAD), agree to offer its services for the purpose of enabling the lodging, authentication and verification of academic awards through the NAD.

Therefore this agreement is entered into between the first part and the other part for a term which is coterminous with the appointment of the other part as Depository by UGC. Provided further that the first part shall ensure that provisions of General Financial Rules, 2017 (as amended from time to time)/State Government Financial rules(as applicable), and the Central Vigilance Commission guidelines and extant Rules, Regulations and Acts are strictly adhered to, while entering into this agreement.

Service Level Agreement (SLA) defines the terms of the other part's responsibility in ensuring the timely delivery of the deliverables and the correctness of the same.

THE PARTIES AGREE AS FOLLOWS:

1. Purpose

- The objective of this Agreement is for the first part to enter into an understanding with the other part to enable the first part to lodge the academic awards of its students/awardees from the current academic year and also for previous academic years in the NAD Portal.

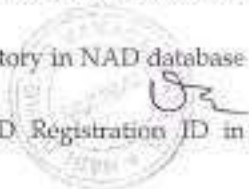
2. Obligations of the first part

- a) The first part shall provide the necessary information such as Award templates, data masters, student identity details, Aadhar, NAD ID of the student etc. etc to the other part.
- b) The first part shall review and confirm the, master data, Award Images and Award data lodged in NAD system.
- c) The first part shall issue necessary administrative and procedural instructions as are necessary to bring and mandate use of NAD services.
- d) The first part shall lodge the digitally signed XML data and Images of all the academic awards to the other part before issue of the academic awards.
- e) The first part may take necessary steps to popularize the use of the system and facilitate expansion of the system usage.
- f) The accuracy of the data of academic awards and student's identity provided by the first part to the other part, shall be the sole responsibility of the first part. The other part shall avail the data from the first part on "AS IS" basis.
- g) The first part shall ensure that the data downloaded by the authorized users of the first part is used only for authorized purposes.
- h) The first part shall ensure to revoke the access of such of its officials who are no longer required to access NAD system for uploading / downloading information or using NAD system.
- i) The first part shall identify the officials to be trained for using NAD system and arrange to set-up training programs and issue internal instructions in this regard.
- j) The first part shall appoint and notify project coordinators from its side who will meet with the other part on a regular basis and provide necessary guidance, support and review the progress made.

3. Obligations of the other part

The other part shall provide system features and perform incidental services as may be necessary to:

- h. Register students in NAD, based on Aadhaar / Unique NAD ID;
- i. Map academic awards to concerned student on the basis of Aadhaar ID or the verified NAD-ID seeded in the Award data;
- j. Maintain the authenticity, integrity and confidentiality of its digital depository in NAD database and block access to any unauthorized users;
- k. Mandatory inclusion of Student's identity details i.e. Aadhaar / NAD Registration ID in Academic Awards made available from NAD;

- l. Allow lodging of academic awards by first part in NAD system in XML data formats/ image format and after applying due process of internal data review, validations, authorization and submitted to NAD with Digital Signature Certificates; both data and image format would be required for uploading/lodging of academic awards in the NAD;
- m. Ensure that all data lodged by the first part remain secure in its digital depository in the NAD and no data loss happens due to destruction, unauthorized manipulation, archiving etc;
- n. Ensure that the academic awards lodged by the first part in the digital depository in NAD is, at all times, accessible online to either the first part, or the concerned awardee/ student or to a person authorized by the concerned awardee/student to access his/her award.
- o. Ensure that the academic awards lodged by the first part facilitate online interaction and exchange of information with the Central Identities Data Repository created by the Unique Identification Authority of India.;
- p. Ensure that the academic awards lodged by the first part are compliant with the Digital Locker technology of MeitY.
- q. Ensure that the academic awards lodged by the first part are transmitted to the other depository/ies in NAD in mutually agreed format between the digital depositories and also therefore to ensure inter-operability of system design and software between them. Syncing of data shall take place, between the two depositories in the NAD in order to resolve transmission errors, on multiple occasions in a day.
- r. Report and confirm back to the first part, after lodging of records, indicating, inter-alia, the NAD ID of the student and the Individual records/certificate ID created against each record.
- s. Provide/share the academic award data only upon receipt of consent from the student.
- t. Make available for verification data relating to academic award to Authorized Users with prior consent of the student.
- u. Provide Reports/Statistics or authenticated copy/ies of any specific academic award pertaining to any student/s in the digital depository when so requested in writing by any Statutory/Regulatory authority subject to approval by UGC.
- v. Not to use the data for any other purpose than as defined under this agreement.
- w. Perform such other duties as may be mutually agreed between the first part and the other part.
- x. The source course/object code together with any related materials or documentation shall remain the property of the other part. However, the same shall be shared by the other part with UGC as and when required.
- y. Consent from the student for sharing of the academic awards/data shall not be required in cases like verification sought by statutory bodies/constitutional bodies/investigating agencies during the course of any enquiry/investigation.
- z. If the student chooses to shift his account from one constituent depository of NAD to the other, the other part shall ensure seamless transfer of registration details and records.
- aa. Where an inspection or enquiry or investigation is undertaken by the UGC, the other part or its shareholder or associate and every manager, director, managing director, chairperson or officer and other employee of depository shall co-operate with the investigation team.

4. Process of verification and authentication

- a. A person requiring verification and authentication of any specific academic award in the NAD will register on the depository system after complying with a process of KYC and on the payment of applicable charges.
- b. The other part shall, on the same day (within 24 hours), the day on which such application is received, verify and authenticate the specific academic award, if lodged in the digital depository, or inform the applicant of the non-availability of such academic award with it on the same day (within 24 hours)/next working day (in case the same day is a holiday) and would refund the charges paid by the applicant, within two working days in case the academic award is not lodged with the digital depository. However, the third party verification would be subject to the consent of the student concerned and the period of same day would apply only after receiving the consent of the concerned student.

5. Reports

- a. The other part shall provide tools to the first part for checking the progress of the project. This shall include the department wise, daily, weekly, monthly and overall progress.
- b. The other part shall provide prescribed MIS reports as per requirements to the first part as well as to the UGC.
- c. The format, content, periodicity and other information related to reports shall be discussed, approved in writing and finalized with the other part.

6. Training

- a. The other part would provide training to the identified Staff of the first part. The training would happen in the premises notified / provided by the first part.
- b. The training shall be conducted in batches of 25 each. The other part will train and make the staff of the first part conversant with the processes involved in the lodging of academic awards and other related processes in the digital depository.
- c. The training shall be carried out as per mutually convenient timelines.

7. Payment Terms

- a. The other part shall notify the charges/tariffs payable by all users in the form of ceilings on each of the NAD services and the same shall be prominently displayed on its website.
- b. Payment for any service(s) shall be made by the first part as per the rates as agreed between the first part and the other part.
- c. The charges agreed upon after following due process between the first part for any service(s) being availed by it and the other part shall not exceed the corresponding charge ceilings as notified by the other part and published on its website.
- d. The list of various service charges is at Annexure A. These rates cannot be modified to the disadvantage of the first part/students of the first part for the first two years or till 30th September, 2019 whichever is earlier.
- e. In case the notified tariffs and charges against the NAD services are found unreasonable at any stage, the competent authority as decided by the Government may form an investigation team to look at the reasonableness of the tariff/charges and its order on the matter shall be final and binding on the other part.

8. Hardware & Software Infrastructure

8.1. Infrastructure

- a. The other part shall use its own infrastructure. This shall include, all hardware as is required for the successful operation, maintenance and implementation of the Project;
- b. The other part shall host the server infrastructure of digital depository of NAD in a data centre facility as decided by it;

- c. The other part shall deploy its own human resource / vendor for all the aforementioned activities and would deploy adequately skilled manpower resources to implement NAD within the specified time.
- d. The other part shall use its own hardware and licensed software including other software such as required for this application.
- e. The application software will be a web based application.
- f. The NAD system comprising depositories/portal/IT infrastructure/stakeholders should adhere to the Information Technology Act 2000 and all amendments thereof.
- g. The two depositories should also have Disaster Recovery (DR) sites highlighting the DR type and location.
- h. The web-based NAD application provided by the two depositories should meet the Uptime requirement of at least 99.5%.
- i. The website of NAD should be GIGW compliant.
- j. The other part should comply with all technical audit requirements as prescribed by UGC from time to time and shall publish such reports and certificates in their website. However, the first part, if it so desires to conduct an additional periodic Vulnerability Assessment Penetration Testing (VAPT) or any such other technical audit, may do so either through its own technical cell or through any other agency at its own cost.

8.2. Archival and Duration of storage

The academic awards data shall be stored on the SAN (Storage Area Network). The other part shall have a well designed archival facility with an audit trail for NAD system. The UGC shall define the time limit (in years) for archiving the data (i.e. years after which the academic awards would be archived).

8.3. Ownership of Hardware, Software & Data

The ownership of hardware and software resources deployed by the other part shall rest with it. The data received by the other part from the first part shall, at all times, remain the exclusive property of the first part.

9. Confidentiality

The data/academic awards are provided by the first part to the other part for hosting on the NAD portal for the purpose of being ultimately downloaded by various stakeholders. Such data/academic awards shall be considered as "Confidential Information" from the date on which it is received by the other part (as per the process of supply of data that has been mutually agreed to between the first part and the other part in writing) till the date on which it is hosted on the NAD portal and made available to public at large. The other part shall ensure complete confidentiality of such data/academic awards provided by the first part, until the time it is hosted on NAD portal and it agrees to limit disclosure of confidential information to employees, software developers on a "need to know" basis. The other part shall not make or allow any of its employees, developers or agents working on the NAD project to make any unauthorized use of the confidential information for any purpose directly or indirectly. Employees, agents and developers working on NAD project shall be underwritten obligations of confidence and non-use with respect to such confidential information received thereto. The other part will be responsible to ensure that no piece of confidential information will be passed on to any other third party without written permission of the first part or any Official authorised by the first part. Adequate provisions shall be made not to allow unrestricted access to such confidential information to employees who are not involved on the NAD Project.

The other part may disclose such Confidential data only to the extent the other part is required to disclose on account of order of any competent court or tribunal provided however that while disclosing such data, the other part shall keep the first part informed of the same while a prior notice unless such notice is prohibited by applicable law.

Provided further that both the first and other part shall maintain the confidentiality of Aadhar information as specified under the the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016

9.1. Exceptions. Notwithstanding the above, the other part will have no liability to the first part with regard to any Confidential Information of the first part which the other part can demonstrate:

- a) was in the public domain at the time it was disclosed to the other part or has become in the public domain through no fault of the other part;
- b) was known to the other part through no breach of any other confidentiality agreement at the time of disclosure, as evidenced by the other part's files in existence at the time of disclosure;
- c) was independently developed by the other part as evidenced by the other part's files in existence at the time of disclosure;

10. Service Quality

- a) The other part shall comply with the provisions as stipulated in the tripartite agreement carried out between UGC and depositories.
- b) The other part shall strictly follow the uptime application norms as devised and amended from time to time by Ministry of Electronics and Information Technology (MeitY). Further, the other part shall adhere to all applicable norms of MeitY to make NAD system efficient and user-friendly.
- c) The other part shall use the data provided to them by the first part strictly in the manner as stipulated in the tripartite agreement (between UGC and depositories)/ Agreement (between first part and second part) and in no other manner. In the event of any misuse of data by the other part by way of interpolations or tampering of the data provided to them by the first part, shall be dealt with as per the penal provisions provided under the Indian Law.


11. Indemnity

The Indemnifying Party undertakes to indemnify and hold harmless the Indemnified Party from and against all losses, claims or damages to tangible personal property arising in favor of any person, corporation or other entity (including the Indemnified Party) attributable to:
 - a. the Indemnifying Party's breach or non performance of any of the Indemnifying Party's undertakings, warranties, covenants, declarations or obligations under this Agreement;

12. Term & Termination

12.1. Term

1. The agreement shall be valid initially for a period of two years from the date of signing the agreement but not later than 30th September, 2019 subject to continuity of the appointment of the other part as "Depository" by UGC. 



The Institutes acknowledge that in the absence of any specific agreement to the contrary, all expenses of remuneration, travel, living and allied costs will be determined at the discretion and be the responsibility of the visitor's home Institutions.

All visits of staff and the admission of students will be subject to compliance with entry requirements of the two Institutes.

This MOU is a statement of intention between the Institutes in relation to the areas of cooperation set out above. With the exception of the confidentiality obligations set out below, the university and the Institute do not intend for this to be legally binding.

Whilst this MOU creates no binding obligations on the Institutes, the MOU shall become effective from the date of the last signature and remain in force for a period of five (5) years with the understanding that it may be terminated by either Institute at any time by written notice to the other Institute (but the confidentiality obligations shall remain). Withdrawal from this MOU shall not affect any formal binding agreements already in place between the universities in relation to a specific program or activity.

The Institutes shall ensure that they keep all discussions and all information received by the other Institute in relation to this MOU or a proposed program or activity confidential, and not disclose the content of the discussions, or any proposed program or activity, to any third party.




