STUDENT PLACEMENT AGREEMENT

BETWEEN THE

JAIN VISHVA BHARATI INSTITUTE (DEEMED UNIVERSITY),

This Agreement entered into this on **July 14, 2014** between the Registrar, Jain Vishva Bharati Institute (Deemed University), Ladnun (herein after referred to as the "Institute") and **Director ACEECO India pvt ltd** (herein after referred to as the "AGENCY"), and herein referred to as "Party".

Purpose

The purpose of this Agreement is to establish a relationship between the AGENCY and Institute to facilitate the search for jobs for the Institute's students, in accordance with their educational qualifications, through the professional expertise of the AGENCY and which may further be also determined/amended/moderated/ altered by the University.

Now, therefore, it is mutually agreed between the parties hereto as follows:

Term

The initial term of this Agreement shall be for five years, from **July 14, 2014 to July 13, 2019** with the option to renew the same for up to a year, except that either Party may, at any time, with or without cause, terminate this Agreement by providing the other Party with thirty (30) days advance written notice.

Institute's Obligations

- The Institute will be responsible for developing and carrying out procedures for Student Placement Camps and disseminate information in this regard
- The University will provide to Agency, supervising professionals for sensitizing the job providers and also shall publish the student information, in which details pertaining to student's achievements would be published, in addition to any other such documentation as required in accordance with the expectations of the prospective employers.
- The Institute will be responsible for verifying the data in regard of Students.
- The Institute will designate an individual to serve as the primary liaison to AGENCY for purposes of this Agreement.

Agency's Obligations

- ❖ AGENCY shall retain the ultimate control and authority over all on-site aspects of e-placement/physical services relating to the employment of the students,
- ❖ AGENCY will provide orientation to Students, participating in the Placement Camp/ Job Fair, either through electronically or in a physical form, as the case may be,
- ❖ AGENCY will inform the students about the hours of jobs, place of duties, provision of leave, conditions of its premises, standards of conduct, confidentiality and facilities, package of compensation, safety procedures and operations.
- ❖ AGENCY shall provide Students records to the prospective employers, under the supervision of the liaison officer, as designated by the Institute.
- ❖ AGENCY shall collect a feedback from the students and also from the prospective employers, joining the camp/fair and submit to the Registrar for the needful.


General Provisions

1. The Institute shall inform each participating student about maintenance of confidentiality of AGENCY. Any breach of confidentiality by a participating student shall be a ground for immediate termination of the placement facility.

2. Nothing in this Agreement shall be construed as establishing a partnership, joint venture or similar relationship between the Institute and AGENCY.
3. Nothing in this Agreement shall be construed to authorize either Party to act as agent for the other, and neither party shall be liable for the wrongful acts or negligence of the other while acting in the course or scope of their employment while performing the duties undertaken pursuant to this Agreement.
