All the members of CIQA discussed and approved the time table of online annual exam of Distance Mode due to pandemic.

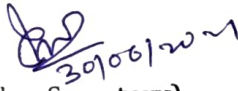
Item No--2021/10/08: To discuss about the Quality Maintain in different aspects of ODL

Item No-2020/10/09: Any other with the permission of the chair.

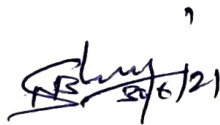
No other matter was placed before the CIQA.
