MEMORANDUM AND ARTICLES OF ASSOCIATION

1. Name, Address and Registration details of the Society registered for the Deemed-to-be University.

The name of society shall be the Jain Vishva Bharati Institute, Ladnun -341306 Dist. Nagaur (Rajasthan) registered under the Rajasthan Societies Registration Act. 1958 vide Registration No. 43/Nagaur 1991-92, dated 13.11.2007 (hereinafter referred to as the "Institute" or the "Institution").

2. Name of the Institution Deemed-to-be University its approved constituent units/off –campuses/off-shore campuses.

The name of the Institution shall be Jain Vishva Bharati Institute (Deemed-to-be University), Acharya Kalu Kanya Mahavidyalaya, which is a constituent College (U.G.) of Jain Vishva Bharati Institute, Ladnun. No other college/unit is a constitute units/off-campuses/off-shore Campuses of Jain Vishva Bharati Institute, Ladnun, at present.

3. Approved constituent units/off-campuses/off-shore campuses with UGC letter/MHRD/notification and dates.

The Registered Office of the Institution deemed-to-be University shall be situated at Jain Vishva Bharati Campus, Ladnun (District Nagaur) Rajasthan. Acharya Kalu Kanya Mahavidyalaya is a constituent College (U.G.) of Jain Vishva Bharati Institute, Ladnun. No other college/unit is a constitute units/off-campuses/off-shore campuses of Jain Vishva Bharati Institute, Ladnun. The UGC has given its approval vide letter No.F.6-9/87C-cpp/Desk-c, dated 08.07.1991.

4. DEFINITIONS

- (1) "Act" means the University Grants Commission Act, 1956 (3 of 1956);
- (2) "Affiliated college" means a college recognized by, associated with and admitted to the privileges of a University;
- (3) "ANUSHASTA" means the Anushasta (Spiritual and Moral Disciplinarian) of the Institute
- (4) "AUTHORITIES" mean the authorities of the Institute.
- (5) "Board of Studies" means the Board of Studies of a Department of the institution deemed to be University;


- (6) "Campus" means campus (single or multiple locations within the city) of the institution deemed to be University wherein its facilities, faculty, staff, students, and Academic Departments are situated;
- (7) "Centre" means a centre of studies of the institution deemed to be University;
- (8) "College" means any institution whether affiliated college or constituent college, known as such or by any other name and provides undergraduate or postgraduate or Ph.D. programmes or all together, for obtaining any qualification from a University, in accordance with the rules and regulations of such University, which has been recognized as competent by the University Grants Commission to provide such programmes or courses of study;
- (9) "Commission" means the University Grants Commission (UGC) constituted under the Act;
- (10) "Constituent college" means a college operating under the administrative, academic, and financial control of the sponsoring body;
- (11) "Constituent unit" means an academic unit (Schools or centers or departments) of the institution existing on the date of submission of a proposal to declare an institution to be an institution deemed to be University;
- (12) "Department" means a department of studies of the institution deemed to be University;
- (13) "Distinct category" means an existing institution or an institution starting from the beginning with the focus on teaching or research in the unique disciplines or addressing the strategic needs of the country or engaged in the preservation of Indian cultural heritage or preservation of the environment or dedicated to skill development or dedicated to sports or languages or any other discipline, as so determined by the Expert Committee approved by the Chairman of the Commission;
- (14) "Expert Committee" means a committee consisting of academics and other experts from other fields and includes representatives of the statutory bodies and approved by the Chairman of the Commission;



- (15) "Government" means the Department in the Ministry of Education in the Central Government dealing with the higher education;
- (16) "Institute", "institution" or "institution deemed-to-be University" means "Jain Vishva Bharati Institute (Deemed-to-be University)" declared by the Central Government by notification under section 3 of the Act, on the advice of the Commission; and engaged in teaching and research at the undergraduate, post-graduate and higher level;
- (17) "KULADHIPATI", "KULAPATI", and "UPKULAPATI" means the Chancellor, Vice- Chancellor and Pro-Vice-Chancellor of the institution deemed to be University, respectively;
- (18) "KULASACHIVA" means the Kulasachiva (Registrar) of the Institute.
- (19) "Main campus" means the campus of the institution deemed to be University, where its major facilities, faculty, staff, students, academic departments and administration are situated;
- (20) "MoA/Rules" means Memorandum of Association and/or Rules of "Jain Vishva Bharati Institute".
- (21) "NAAC" means the National Assessment and Accreditation Council;
- (22) "NBA" means the National Board of Accreditation;
- (23) "Necessary infrastructure" means the infrastructure required under the norms of the concerned statutory body or the Commission, as the case may be;
- (24) "NEP" means the National Education Policy, 2020;
- (25) "NIDESHAK" means the Nideshak (Director) of a constituent Institution, Department/ Division mainly with Research or Extension activities of the Institute.
- (26) "NIRF" means the National Institutional Ranking Framework;
- (27) "Notification" means a notification issued by the Central Government in the Official Gazette declaring an institution of higher education, as an institution deemed to be University under section 3 of the Act;
- (28) "Off-campus" means the premises of the institution deemed to be University, approved by the Government, other than the main campus or the campuses;

- (29) "Off-shore campus" means the premises of the institution deemed to be University, approved by the Government, outside India, other than the main campus in India;
- (30) "PRABANDHA MANDAL" means the Prabandha Mandal (Executive Council) of the Institute.
- (31) "Processing fee" means the fee to be paid by the applicant institution to the Commission along with the application for processing such application;
- (32) "Regulations" means the University Grants Commission (Institutions deemed to be Universities) Regulations, 2023.
- (33) "RULES & BYE-LAWS" means the Rules & Bye-Laws of the Institute.
- (34) "School" or "faculty" means a school or faculty of studies of the institution deemed to be University;
- (35) "SHIHSTA PARISHAD" means the Shishta Parishad (General Body (of Members)) of the Institute constituted as per rules.
- (36) "SOCIETY" means the Jain Vishva Bharati Institute registered as Society under the Rajasthan Societies Registration Act, 1958.
- (37) "SPONSORING SOCIETY / PARENT SOCIETY / PARENT BODY" means the Jain Vishva Bharati, a society registered under the Rajasthan Societies Registration Act, 1958.
- (38) "Standing Committee" means a committee consisting of academics and other experts from other fields and includes representatives of the statutory bodies and approved by the Chairman of the Commission;
- (39) "Statutory body" means a body constituted under any law for the time being in force for determining or maintaining standards of quality in the relevant areas of higher education, including the All India Council for Technical Education (AICTE), the Bar Council of India (BCI), the Dental Council of India (DCI), the Indian Nursing Council (INC), the National Council for Teacher Education (NCTE) and the National Medical Commission (NMC), or any other statutory body established under an Act of Parliament;
- (40) "Teacher" means professors, associate professors, assistant professors and such other academic staff as may be appointed for imparting instructions or conducting research in the institution

deemed to be University including the adjunct faculty or professor of practice or visiting faculty; and


- (41) "VIDYA PARISHAD" (Academic Council) means the academic council of the institution deemed to be University;
- (42) "VITTA SAMITI" means the Vitta Samiti (Finance Committee) of the Institute.
- (43) "VITTADHIKARI" means the Vittadhikari (Finance Officer) of the Institute.
- (44) "YEAR" means the financial year.

5. OBJECTIVES

Jain Vishva Bharati Institute is solely an educational institution, dedicated to cultivate and practice high ideals of "Anekant" including tolerance and peaceful co-existence for the weal of the mankind at the global level as propagated by the Anushasta. The objectives of the Institution deemed-to-be University shall be:

- (1) To provide for higher education leading to excellence and innovations in such branches of knowledge as may be deemed fit, primarily at undergraduate, post-graduate, and research degree levels, fully conforming to the concept of a University;
- (2) To engage in inter-disciplinary, multi-disciplinary, and trans-disciplinary teaching and research in addition to domain-specific specialization.
- (3) To prioritize research and innovation by establishing start-up incubation centers, technology development hubs, and research centers in emerging fields, enhancing industry-academic collaboration.
- (4) To provide for high-quality teaching and research recognized nationally and globally;
- (5) To recognize, identify and foster the unique capabilities of each student, by sensitizing teachers as well as parents to promote each student's holistic development;
- (6) To provide multi-disciplinary and a holistic education in the faculties of science, engineering, technology, social sciences, arts, humanities, sports and other disciplines;



- (7) To provide flexible and innovative curriculum, which includes credit-based courses and projects in the areas of community engagement and service, environmental education, value-based education, etc.;
- (8) To contribute for social transformation through socially responsive teaching, learning, research, and fieldwork;
- (9) To adopt the provisions of NEP, 2020;
- (10) To strengthen the research ecosystem by establishing Research and Development Cell (RDC).
- (11) To possess such academic and physical infrastructure as may be specified by the Commission or the relevant statutory body, as the case may be; and
- (12) shall have an administrative area, library, lecture halls, labs, hostels, health care, common facilities and recreational facilities.
- (13) To enable creation of institutions deemed to be university under the 'de novo' category devoted to unique and emerging areas of knowledge, not being pursued by conventional or existing institutions - particularly in specific areas of study and research preferably sponsored by the Government of a State / UT or the Central Government regarded as important for strategic needs of the country or for the preservation of our cultural heritage, so determined by a well laid-out process of wide consultation with the eminent peers of academic community;
- (14) To provide for Instruction, Training, Research, Extension and Experimentation in the various branches of learning, make arrangements, take up and impart education in professional courses and award degrees, diploma and certificates as may be permitted under the UGC regulations and /or guidelines and the higher education policies by the Government;
- (15) To provide for research and for advancement of and dissemination of knowledge and extension activities in the Oriental Learning— Prakrit Language and Literature, Pali, Sanskrit, Apabhramsha, Jainology, Philosophy, Religion, Comparative Studies in Philosophy and World Religions, Astrology, Mantravidya, Avadhanvidya (Memonics), Yoga and



Sadhana, Ayurveda, Naturopathy, Colour Therapy, Magnet Therapy, Epigraphy, Paleography, Jeevan Vigyan & Preksha Dhyam (Science of Living & Preksha Meditation) and the fundamental principles of Shramana Culture and such other related and ancilliary or supplementary subjects as may be permitted under the UGC regulations and /or guidelines and the higher education policies by the Government;


- (16) To encourage students of higher education in critical study of the above -mentioned & related disciplines and to equip them with an analytical outlook to discover the elements of social sciences in the various disciplines;
- (17) To provide facilities for study and research & extension in discipline of Indian Yoga with special emphasis on spiritual discipline embedded in the Jain Agamas;
- (18) To edit the original works for a comparative and critical study of the aforesaid & related subjects;
- (19) To prepare and publish reference books such as Dictionary and Encyclopedias on Prakrit Language and Literature, Jain Philosophy and Culture and related aspects; to provide for the teaching of other Indian and foreign languages and research in the context of the aim of the Institute;
- (20) To give special emphasis on the synthesis of the spiritual heritage of the ancient Indian Shramana Culture with the modern scientific outlook in the field of education and research and inculcate amongst students the essential values and ideals of ancient Indian culture and civilization;
- (21) To organize residential community of students and teachers for living together on patterns of ancient Indian Educational Centers and Ashramas;
- (22) To establish courses of study, research & extension and to provide the instruction & extension in such branches of study as the Institute deems appropriate for the advancement of learning and dissemination of knowledge in such disciplines;
- (23) To confer Degrees and to grant Diploma and/or Certificate to persons who have satisfactorily completed the approved courses of study and/or research as may be prescribed and shall

have passed such tests or examinations or successfully completed the assignments as may be prescribed;


- (24) To institute and award visitorships, fellowships, prizes and medals etc.;
- (25) To sanction and award financial assistance in the form of scholarships, stipends, awards, prizes, loans, etc. to students, scholars, researchers, spiritually devoted persons, social workers, and the institutions and to manage and arrange with cost or free for their boarding and lodging;
- (26) To create Trusts, collect funds, raise loans and to plan & prepare scheme for the same, to obtain contributions, grants and financial assistance from the general public, government or non-government organizations and to utilize the same and the income there from for the objects referred to above;
- (27) To build up a corpus of fund of which only the income is to be spent for carrying out the objects of the Institute;
- (28) To acquire, purchase or get or give on lease buildings or land for the Institute conditionally or unconditionally, to construct buildings, roads etc. and to collect and purchase necessary equipment and material for the fulfillment of the aims of the Institute;
- (29) To establish contacts with scholars and philosophers and organize occasional conferences, seminars, discussions, exhibitions etc., and to arrange for reading of papers and to send representatives to other places to fulfill this object;
- (30) To establish campuses of study and research as may be required for the students and scholars of the Institute;
- (31) To undertake suitable extension activities for the public welfare and social advancements;
- (32) To make rules and bye-laws for the conduct of affairs of the Institute and to amend, vary or rescind them from time to time and also to enable the Institute to accept gifts, bequests of land and buildings, and all income thereof;
- (33) To fix, demand and receive fees and other charges as may be necessary;

- (34) To constitute Board of Studies and Research and such other committees as may be necessary for fulfillment of the objects;
- (35) To disseminate the popular aspects of Prakrit and Jain learnings among the common people by holding meetings, conferences, seminars and discourses by inviting eminent scholars etc.;
- (36) To establish and manage hostels and other places of residence for the students, teachers and staff;
- (37) To supervise, control and regulate the discipline of the students of the Institute and to make arrangements for promoting their health, general welfare and cultural and corporate life.
- (38) To create teaching cadres including academic research and extension and administrative, ministerial and field posts for the fulfillment of its objects and to fix the terms and conditions of all appointments;
- (39) To recognize degrees, diplomas and certificates of other educational bodies corporate as equivalent to those of the Institute;
- (40) To establish laboratories as part of the Institute for the practice of Yoga, Meditation and Self-realization and to arrange for the training in these disciplines;
- (41) To publish books, journals, monographs and periodicals and papers in furtherance of the objects of the Institute and to establish a library of CD's;
- (42) To build up and equip an up-to-date library of printed books, manuscripts, journals and periodicals relating to the above mentioned and related subjects and to establish reading rooms;
- (43) To establish museum(s) and preserve rare manuscripts, letters, pictures, stone images, artistic works, and archaeological and historical exhibits;
- (44) To prescribe qualifications for admission to its various classes, training programmes and such other activities;
- (45) To institute awards for outstanding contributions made by individuals or institutions for the promotion of and to the cause of global peace, propagation of Ahimsa, harmony and goodwill and in such other fields of national integration and in

international understanding through literary, scientific or humanistic pursuits in accordance with Rules and Bye-laws adopted from time to time;

- (46) To do all such things as may be conducive, necessary, incidental, complementary, residual for the effective functioning of the Institute in pursuance of its objectives.
- (47) The institution shall be a not-for-profit organization and shall not be engaged in commercialization of higher education, under-graduate, post-graduate and research programmes.

Provided however no object shall be pursued unless permissible under the rules of the UGC.

6. CORPUS FUND

- (1) A corpus fund of rupees twenty-five crores or as decided by the Commission from time to time, shall be created and maintained in the name of the institution deemed to be University;
- (2) The interest accrued on the corpus fund shall be used only for the purpose of further development of the institution deemed to be University; and
- (3) Institutions deemed to be Universities may invest the corpus fund in any suitable scheme or schemes.

7. OFF-CAMPUS AND OFF-SHORE CAMPUS CENTERS

Off-Campus Centre(s) and Off-Shore Campus Centre(s) shall be started by the deemed-to-be university only after prior approval of the UGC/Statutory/Regulatory body.

8. MONITORING

- (1) The Commission shall monitor the performance and academic outcomes of the institutions deemed to be Universities
- (2) The Commission shall decide on the physical verification of an institution deemed to be University or constitute teams for such verification on its own or upon receipt of any complaint against the accuracy and veracity of the information submitted to the Commission and also hosted on the website of the institution.

9. ANUSHASTA (SPIRITUAL AND MORAL DISCIPLINARIAN)

- (1) There shall be an "Anushasta" (Spiritual and Moral Disciplinarian) of the Institute.
- (2) The spiritual fountain-head of the Jain Vishva Bharati-Anuvrat Anushasta Acharya Shri Tulsī of Terapanth Order shall be the first Anushasta of the Institute. The successive Anushasta shall be the succeeding Acharya in the said order.
- (3) The role of the Anushasta in the realm of the institutional set up shall be that of the supreme guide in the spiritual and moral discipline of the Institute. He will, inter-alia, advise/ exhort/ address as and when he feels opportune or on the request of the authorities/Vice-Chancellor of Institute about the advancement of knowledge /learning in the various Departments of the Institute.

10. GOVERNANCE


- (1) The Institution is registered as a not-for profit Society under the Rajasthan Societies Registration Act, 1958.


The sponsoring body shall be exempted from transferring its moveable and immovable assets to the newly created society or trust or company, if such sponsoring body provides a notarized affidavit to the effect that the entire moveable and immovable assets allocated to the institution deemed to be University shall not be leased or otherwise disposed of without the prior permission of the Commission:

PROVIDED also that the sponsoring body shall make available the necessary infrastructure for operating the institution deemed to be University without any rental or other such charges.

- (2) All moveable and immovable assets of the institution deemed to be University shall be used for the purposes of conducting academic activities, promotion of research and related administrative requirements of the institution deemed to be University, including the outreach educational activities.
- (3) The highest governing body of the institution deemed to be University shall be the "Prabandha Mandal" (Executive Council) to be headed by the Vice-Chancellor and consisting of not less than ten and not more than thirteen members.

- (4) The Executive Council shall be the principal executive body of the institution deemed to be University.

11. PRABANDHA MANDAL (EXECUTIVE COUNCIL)

The composition of the Executive Council shall be as under:

- a) Vice-Chancellor – Chairperson;
- b) Pro-Vice-Chancellor, if any;
- c) Two members from amongst the Deans of schools of studies, by rotation, to be appointed by the Vice-Chancellor;
- d) One representative shall be nominated by the Commission;
- e) One Professor, who is not a Dean, by rotation, to be appointed by the Vice-Chancellor;
- f) One Associate Professor, by rotation, to be appointed by the Vice-Chancellor;
- g) One Assistant Professor, by rotation, to be appointed by the Vice-Chancellor;
- h) Two academicians shall be nominated by the Vice-Chancellor in consultation with the Anushasta;
- i) Two nominees of the Sponsoring Body, who shall be the ex-officio President and Secretary of the Sponsoring Body; and
- j) The Registrar, who shall be the ex-officio Secretary of the Executive Council.

12. TENURE OF THE MEMBERS OF THE EXECUTIVE COUNCIL

- (1) The nominees of the Sponsoring Body, namely its President and Secretary, shall serve as ex officio members of the Executive Council and shall continue to hold such membership for the period during which they remain in their respective offices in the Sponsoring Body.
- (2) All other members of the Executive Council, other than the Vice-Chancellor, the Pro-Vice-Chancellor, and the nominees of the Sponsoring Body, shall hold office for a term of three years;
Provided that—

- a) In the case of the Deans, the term shall be three years or until they cease to hold the office of Dean, whichever is earlier; and
- b) The members appointed by the Vice-Chancellor from among the Professor, Associate Professor and Assistant Professor categories shall hold office for a period of one year or until they cease to be teachers of the University, whichever is earlier.

13. POWERS AND LIMITATIONS OF EXECUTIVE COUNCIL:


- (1) The Executive Council shall have the power of management and administration of the institution deemed to be University.



- (2) The Executive Council shall be the final decision-making body of the institution deemed to be University in respect of every matter of the institution deemed to be University, including academic, administrative, personnel, financial, and developmental matters.
- (3) Subject to the provisions of these regulations and the rules of the institution deemed to be University, the Executive Council shall, in addition to all other powers vested in it, have the following powers:
- (i) to appoint such Professors, Associate Professors, Assistant Professors and other academic staff, including Chairs, as may be necessary, on the recommendation of the Selection Committee constituted for the said purpose and to fill up temporary vacancies therein;
 - (ii) to provide for the appointment of Visiting Professors, Emeritus Professors, Professor of Practice, Consultants, Scholars, etc., and determine the terms and conditions of such appointments;
 - (iii) to regulate and enforce discipline amongst the employees of the institution in accordance with the rules of the institution deemed to be University;
 - (iv) to exercise such other powers and perform such other duties as may be conferred or imposed on it by the rules and regulations of the institution deemed to be University;
 - (v) to make rules and regulations for the institution deemed to be University; and
- (4) The Executive Council has the power to frame the Rules of the Institution deemed to be university that may provide for all or any of the following matters:
- (i) establishment of Departments of teaching;
 - (ii) courses of study to be laid down for all degrees, diplomas and certificates of the Institution;
 - (iii) grant of academic awards (such as degrees and diplomas) and distinctions;
 - (iv) admission of students to the Institution and their enrolment as such;

- (v) the fees to be charged for courses of study and for admission to the examinations, degrees, diplomas and certificates of the Institution;
- (vii) conduct of examinations, appointment of examiners and approval and publication of results thereof;
- (vii) institution of award of fellowships, scholarships, studentships, medals and prizes and prescription of the conditions thereof;
- (viii) maintenance of discipline among the students;
- (ix) maintenance of discipline among the employees;
- (x) establishment of halls of residence and conditions of residence and health of the students;
- (xi) classification, emoluments, method of appointment and determination of the terms and conditions of service of the staff;
- (xii) such other powers, functions and duties of the Academic Council as are not mentioned elsewhere;
- (xiii) constitution, powers and functions of the Planning & Monitoring Board
- (xiv) Powers and functions of the Board of Studies;
- (xv) composition, powers and functions of the Grievance Redress Mechanism;
- (xvi) prescribing persons as such other officers of the Institution;
- (xvii) such other powers and functions of the Vice-Chancellor as are not specified elsewhere;
- (xviii) emoluments, terms and conditions of service of the Registrar;
- (xix) emoluments, terms and conditions of service of the Finance Officer;
- (xx) constitution of pension, provident fund, insurance etc. for the benefit of the officers, teachers, and the other staff;
- (xxi) establishment of special centers;
- (xxii) creation, composition and functions of any committees or body, which is considered necessary for the work of the Institution;

- (xxiv) procedure for convening of meeting of any authority or committee;

- (xxvi) constitution of any other body as an authority of the Institution;
- (xxvii) all other matters by the Regulation or the Rules may be provided but no rule shall be made affecting the condition of residence, health, discipline, admission, enrolment of students, conditions, mode of appointments, duties of examiners, conduct of and standard of examinations or any course of study without consulting the Academic Council.
- (5) In addition to all other powers vested in it, have the following powers, namely:
- (i) to establish, on the advice of the Academic Council, Divisions and Departments for the academic work and functions of the Institution and to allocate areas of study, teaching and research to them;
- (ii) to create administrative, ministerial and other necessary posts in terms of the cadres laid down and to make appointment thereof in consultation with the Finance Committee;
- (iii) to constitute, for the benefit of the teaching, academic, technical, administrative and other staff, such pension, insurance, provident fund and gratuity as it may deem fit and aid in the establishment and support of Association, Institutions, Funds, Trusts and conveyances calculated to benefit the staff and the students of the Institution;
- (iv) to entertain and adjudicate upon and, if thought fit, to redress any grievances of the employees and students of the Institution;


- (v) to grant leave of absence to the Vice-Chancellor and to make necessary arrangements for carrying on his/her functions during the period of absence;
- (vi) to approve the award of Degrees and Diplomas based on the results of examinations and tests and to confer, grant or award Degrees, Diplomas, Certificates and other academic titles and distinctions;
- (vii) to fix the emoluments and traveling and other allowances of examiners, moderators, tabulators and such other personnel appointed for examinations in consultation with the Academic Council and the Finance Committee;
- (viii) to institute Fellowships, including Traveling Fellowships, Scholarships, Studentships, Medals and Prizes in accordance with the Rules to be framed for the purpose;
- (ix) to advise the Society (if any) on matters regarding acquisition, management and disposal of any immovable property on behalf of the Institution;
- (x) to purchase, take on lease or accept as gift or otherwise any land or buildings or works which may be necessary or convenient for the purpose of the Institution, on such terms and conditions as it may deem fit and proper, and to construct or alter and maintain any such building(s) or work(s);
- (xi) to transfer or accept transfers of any movable property on behalf of the Institution;
- (xii) to execute in consultation with the Sponsoring Society conveyance, transfer Government Securities, re-conveyances, mortgages, leases, bonds, licenses and agreements in respect of property, movable or immovable, belonging to the Institution or to be acquired for the purposes of the Institution;
- (xiii) to issue appeals for funds for carrying out the objectives of the Institution and, consistent with the provisions of the objectives, to receive grants, donations, contributions, gifts, prizes, scholarship fees and other moneys, to give grants and donations, to award prizes,


scholarships, etc.; mortgages, promissory notes or other obligations or securities funded or based on any of the properties and assets of the Institution, or without any securities;

- (xiv) to raise and borrow money on bonds, upon such terms and conditions as it may think fit and to pay out of the funds of the Institution, all expenses incidental to the raising of money and to repay and redeem the money borrowed;
- (xv) to draw and accept and make and endorse discount and negotiate Government of India's and other promissory notes, bills of exchange, cheques or other negotiable instruments;
- (xvi) to maintain a fund to which shall be credited:
- (xvii) all moneys provided by the Central or State / UT Government(s) /University Grants Commission;
- (xviii) all fees and other charges received by the Institution;
- (xix) all money received by the Institution as grants, gifts, donations, benefactions, bequest or transfers and
- (xx) all money received by the Institution in any other manner or from any other source;
- (xxi) to open account or accounts of the Institution with anyone or more scheduled banks and to lay down the procedure for operating the same;
- (xxii) to deposit all moneys credited to the funds in scheduled banks or to invest them in consultation with the Finance Committee;
- (xxiii) to invest the funds of the Institution or money entrusted to the Institution in or upon such securities and in such manner as it may deem fit and from time to time transpose any investment;
- (xxiv) to maintain proper accounts and other relevant records and prepare Annual Statements of Accounts, including the balance sheet for every previous financial year, in such form as may be prescribed by the Regulations / Bye-

Laws, get the same audited and submit the same to the Sponsoring society and to the respective statutory authorities where the same is required to be submitted;

- (xxv) to manage, regulate and administer the revenue, the finance, accounts, investments, properties, business and all other administrative affairs of the Institution and for that purpose to appoint such agent or agents as it may deem fit;
- (xxvi) to provide building or buildings, premises, furniture, fittings, equipments, appliances and other facilities required for carrying on the work of the Institution;
- (xxvii) to establish, maintain and manage residencies for faculty and staff and hostels for the students of the Institution;
- (xxviii) to recognize and maintain control and supervision on hostels owned and managed by other agencies for the students of the Institution and to rescind such recognition;
- (xxix) to appoint such committees for such purpose and with such powers as the Executive Council may think fit and to co-opt such persons on these Committees as it thinks fit;
- (xxx) to appoint in order to execute an instrument or transact any business of the Institution, any person as attorney of the Institution with such powers as it may deem fit
- (xxxi) to appoint Auditor(s) for the ensuing year;
- (xxxii) to select an emblem and to have a common seal for the Institution and to provide for the custody and use of such seal;
- (xxxiii) to conduct all administrative affairs of the Institution not otherwise specifically provided and for such purposes appoint such officers, Financial Advisors and other Advisors as may be required for efficient management, administration and running of the Institution;
- (xxxiv) to take all necessary decisions for the smooth and efficient functioning of the Institution;
- (xxxv) to constitute such Standing Committee or Ad hoc Committee or Committees, by resolution, for such

purposes and with such powers as the Council may think fit for discharging any function of the Institution deemed to be university or for inquiring into, reporting and advising upon any matter of the Institution; and

(xxxvi) to co-opt such persons on the Standing Committees or Ad-hoc Committees, as it may consider suitable.

14. MEETINGS OF EXECUTIVE COUNCIL:

- (1) The Executive Council shall meet at least four times a year (minimum two in one semester), with not less than seven days' prior notice given before every meeting of the Executive Council and emergency meetings may be convened at a shorter notice, for reasons to be recorded in writing for such emergency meeting.
- (2) One-third of the total number of members of the Executive Council shall form the quorum for the meeting
- (3) In the absence of the Vice-Chancellor, the Pro-Vice Chancellor shall preside over the meeting; and where there is no Pro-Vice-Chancellor in an institution deemed to be University, a member chosen by the other members of the Executive Council present at the meeting, shall preside over the meeting.
- (4) Every member of the Executive Council including the Chairperson, shall have one vote and the decisions at the meetings of the Executive Council shall be taken by simple majority; and in case of a tie, the Chairperson shall have a casting vote.
- (5) Any business, which may be urgent in nature, may be carried out by circulation amongst its members.
- (6) A copy of the minutes of each meeting shall be furnished to the Chancellor of the institution deemed to be University, as soon as possible after the convening of the meeting.

15. TERMINATION OF MEMBERSHIP:

If a member other than the Vice-Chancellor and those representing the teachers, accepts a full- time appointment in the institution deemed to be University or fails to attend three consecutive meetings

of the Executive Council, without proper leave of absence, such member shall cease to be a member of the Executive Council.

16. DELEGATION OF POWERS OF THE EXECUTIVE COUNCIL:

The Executive Council may, by a resolution, delegate to the Vice Chancellor or any other officer or faculty or to a Committee of officers or faculties of the institution deemed to be University, such powers as it may deem fit, subject to the condition that the action taken by the Vice-Chancellor or the officer or faculty or the Committee in the exercise of the powers so delegated, shall be reported at the next meeting of the Executive Council.


17. OTHER AUTHORITIES OF THE INSTITUTION

The following shall be the authorities of the Institution deemed to be university:

- (1) Vidya Parishad (Academic Council)
- (2) Vitta Samiti (Finance Committee)
- (3) Board of Studies
- (4) Such Other Authorities as may be declared under the Rules to be authorities of the Institution deemed to be university. Shishta Parishad (General Body (of Members)) is declared as other authority under the rules of the institute.

18. ACADEMIC COUNCIL:

- (1) The Academic Council shall be the principal academic body of the institution deemed to be University and shall, subject to the provision of the rules of the institution deemed to be University, co-ordinate and exercise general supervision over the academic policy of the institution deemed to be University.
- (2) The composition of the Academic Council shall be as under:
 - (i) Vice Chancellor - Chairperson;
 - (ii) Pro Vice-Chancellor (if any);
 - (iii) Deans of faculties of the schools and heads of the departments or centers;



- (iv) up to ten Professors (excluding those who are Deans of schools and heads of departments or centers) by rotation, to be nominated by the Vice-Chancellor giving due regard to the representation of different schools or departments or centers;
- (v) up to five Associate Professors from departments or centers other than the heads of the departments or centers, by rotation, to be appointed by the Vice-Chancellor;
- (vi) up to five Assistant Professors from the departments or centers other than the heads of the departments or centers, by rotation, to be appointed by the Vice-Chancellor;
- (vii) six persons of repute from amongst the educationists or experts for their specialized knowledge, who are not in the service of the institution deemed to be University, nominated by the Vice-Chancellor on the advice of Anushasta;
- (viii) the Registrar, who shall be the ex-officio Secretary of the Academic Council.
- (3) The representation of different categories shall be through rotation and not through an election and the term of members, other than the ex-officio members, shall be three years and the Controller of Examination shall be the permanent invitee to the meetings of the Academic Council.

19. POWERS AND FUNCTIONS OF ACADEMIC COUNCIL:

Subject to the provisions of these regulations and rules of the institution deemed to be University, the Academic Council shall, in addition to all other powers vested in it, have the following powers, namely:

- (1) to exercise general supervision over the academic policies of the institution deemed to be University and to give directions regarding methods of instruction, co-ordination of teaching among departments or faculties or schools or centers, evaluation of research and improvement of academic standards;
- (2) to bring about and promote inter-departmental, inter-faculty, inter-school, inter-center co-ordination and to establish or

appoint such committees or boards, as may be deemed necessary for the purpose;

- (3) to consider matters of general academic interest either on its own initiative, or on a reference by a department or faculty or school or centre or the Executive Council, and to take appropriate action thereon;
- (4) to prescribe courses or programmes of study leading to degree and diploma of the institution deemed to be University;
- (5) to make arrangements for the conduct of examinations in conformity with the rules and bye-laws of the institution deemed to be University;
- (6) to maintain proper standards of the examination;
- (7) to recognize diplomas and degrees of universities and other Institutions and to determine equivalence with the diplomas and degrees of the institution deemed to be University;
- (8) to institute Fellowships, Scholarships, Medals, Prizes, etc.;
- (9) to frame rules covering the academic functioning of the institution deemed to be University, admissions, examinations, award of fellowships and studentships, free-ships, concessions, attendance, discipline, residence, etc.;
- (10) to take a periodical review of the activities of the departments or centers and to take appropriate action to maintain and improve the standards of instruction;
- (11) to recommend the institution of teaching posts (Professors, Associate Professors, and Assistant Professors) to the Executive Council;
- (12) to make recommendations to the Executive Council for the establishment or abolition of departments or centers or schools or faculties, etc.
- (13) to make recommendations to the Executive Council; and
- (14) to exercise such other powers and to perform such other duties, as may be conferred or imposed upon it by the rules of the institution deemed to be University.

20. MEETING OF THE ACADEMIC COUNCIL:

- (1) The Academic Council shall meet as often as necessary but not less than four times (at least two times in a semester) during an

academic year with not less than seven days prior notice being given before every meeting of the Academic Council and emergency meetings may be convened at a shorter notice, for reasons to be recorded in writing for such emergency meeting.

- (2) One-third of the total number of members of the Academic Council shall constitute the quorum for the meeting of the Academic Council.
- (3) Each member, including its Chairperson, shall have one vote, and decisions at the meetings of the Academic Council shall be taken by simple majority; and in case of a tie, the Chairperson shall have a casting vote.
- (4) Any business that may be necessary for the Academic Council to perform, which may be urgent in nature, may be carried out by circulation amongst its members.

21. VITTA SAMITI (FINANCE COMMITTEE):

- (1) The composition of the Finance Committee shall be:
 - (i) Vice Chancellor - Chairperson;
 - (ii) Pro Vice-Chancellor, if any;
 - (iii) one person nominated by the society;
 - (iv) three persons to be nominated by the Executive Council, out of whom at least one shall be a member of the Executive Council;
 - (v) one representative nominated by the Commission;
 - (vi) three persons to be nominated by the Chancellor at the advice of Anushasta;
 - (vii) Finance Officer-Secretary- ex officio
- (2) All members of the Finance Committee other than ex-officio member shall hold office for a term of three years.
- (3) The Finance Committee shall meet at least four times in an academic year (at least twice each semester), with not less than seven days prior notice being given before every meeting of the Finance Committee, to examine the accounts and scrutinize the proposals for expenditure and one-third of the total number of members of the Finance Committee shall form the quorum for a meeting. Emergency meetings may be convened at a shorter

notice, for reasons to be recorded in writing for such emergency meeting, and any business, which may be urgent in nature, may be carried out by circulation amongst its members.

- (4) All proposals relating to the creation of posts and those items which have not been included in the Budget, shall be examined by the Finance Committee before the Executive Council considers them and to decide waiver in fees, the establishment of scholarships, freship and any other financial benefits.
- (5) The annual accounts and financial estimates of the institution deemed to be University prepared by the Finance Officer shall be laid before the Finance Committee for consideration and comments and thereafter the same shall be submitted to the Executive Council for approval.
- (6) The Finance Committee shall recommend limits for the total recurring and non-recurring expenditures for the year, based on the income and resources of the institution deemed to be University.

22. BOARD OF STUDIES:

- (1) There shall be one Board of Studies for each department or school of the institution deemed to be University. The composition of the Board of Studies shall be:
 - (i) Dean of school or Head of the department - Chairperson;
 - (ii) all Professors of the school or department;
 - (iii) two Associate Professors of the school or department, by rotation;
 - (iv) two Assistant Professors of the school or department, by rotation; and
 - (v) two external experts to be co-opted for their specialized knowledge.
- (2) Subject to the overall control and supervision of the Academic Council, the functions of a Board of Studies shall be to approve subjects for research for various degrees and other requirements of research degrees and to recommend to the concerned School Board institution deemed to be University regarding:
 - (i) courses of studies;

- (ii) appointment of supervisors for research; and
 - (iii) measures for the improvement of the standards of teaching and research.
- (3) The powers and functions of the Board of Studies shall be prescribed by the rules of the institution deemed to be University.

23. SHISHTA PARISHAD (GENERAL BODY (OF MEMBERS)):

(1) Composition of General Body (of Members)

The General Body (of Members) shall consist of the following:

A. Ex-Officio members:

- i. The Kuladhipati, who shall be the Chairman of the General Body (of Members);
- ii. Prati Kuladhipati (Pro. Chancellor) of the Institute, if any;
- iii. The Kulpati of the Institute;
- iv. Pro Vice-Chancellor of the Institute, if any;
- v. Two from the heads of department to be nominated by the Kulpati;
- vi. The President of Sponsoring Society or Trust;
- vii. The Secretary of Sponsoring Society or Trust;


Such other ex-officio members not exceeding two, as may be provided for in the Bye-laws;


B. Founding Members:

- viii. One representative of the founding members of the Institute to be nominated by the Kuladhipati;

C. Life Members:

- ix. Any individual who has made a donation to the Institute at one time of an amount or of property valued Rupees five lakhs or more shall be admitted as a member for the whole of his life. However, the amount shall stand increased to Rupees Fifty Lakhs or more (w.e.f. 1st June, 2012).

Provided that in the case of a corporate body including body of individuals or trust or society such a donation shall be Rupees ten lakhs or more and the membership shall last for a period of 10 years from the date of acceptance by the Institute of such donation.

Provided further that w.e.f. 1st June, 2012 a person shall be deemed-to-be a member on recommendation by the Prabandh Mandal (Executive Council) to Chancellor and Chancellor will nominate them.

Provided further that w.e.f. 1st June, 2012 corporate body, body of individuals, trust or society shall not be appointed as a member.

D. Members by Representation:

The following shall be members by representation:

- x. Four members engaged in promotion of Jainism and Prakrit Learning, Jain Culture and allied subjects or members of Jain institutions to be nominated by the Sponsoring Society or Trust;
- xi. Four Jain Scholars of whom at least one should be a woman member to be nominated by the Anushasta;
- xii. Four nominees of the Kuladhipati from amongst Philosophers, Philanthropists, Educationists and Social Workers;
- xiii. Such other ex-officio members not exceeding two as may be provided for in the bye-laws.

E. Associate Members:

The Kuladhipati may nominate not exceeding five persons as associate members who have the commitment to the achievement of the objects of the Institute during his tenure.

The Kulasachiva shall be the non-member Secretary.

The total strength of the General Body (of Members) at any one time shall not exceed seventy-five.

(2) Term of Office:

The term of Office of the members of the General Body (of Members) other than ex-officio members, Life members and


Associate members shall be two years provided that a person appointed as a member of the General Body (of Members) by virtue of his holding an office of appointment shall cease to be a member of the General Body (of Members) when he ceases to hold the office or appointment.

(3) Membership Roll:

The Institute shall keep roll of members of the General Body (of Members) stating therein the name, address and occupation of every member. Every member of the General Body (of Members) shall sign the roll.

(4) Meetings of the General Body (of Members):

- (a) The Kuladhipati shall preside over the meeting of the General Body (of Members) and in his absence the Kulapati shall preside.
- (b) The annual meeting of the General Body (of Members) shall be held on the date fixed by the Kulapati.
- (c) At the annual meeting of the General Body (of Members) a report of the Executive Council on the working of the University of the Preceding Year together with the Audited Accounts and the Budget estimates of the University for the next year shall be presented for consideration and approval.
- (d) The Kulapati may, whenever he/she thinks fit, shall, upon a requisition in writing signed by not less than thirteen members of the Parishad, convene a special meeting of the General Body (of Members).
- (e) Any emergent business necessary for the General Body (of Members) to transact may be carried out by circulation amongst all the members and any resolution so circulated and approved by a majority of the members signing shall be as effective and binding as if such resolution has been passed at a meeting of the General Body (of Members); provided that at least half the members of the General Body (of Members) have recorded their views on the resolution.
- (f) The ruling of the Kuladhipati in all matters of procedure shall be final.

- (g) The quorum of the meeting of the General Body (of Members) shall be one-fourth of the effective strength of the members of the University present.
- (h) In every meeting of the General Body (of Members) each member present in person shall have one vote and decision of the Parishad shall be by majority vote of the members present and voting. In event of the equality of the votes the Chairman shall have a second or casting vote.
- (i) Director of the Company coming along with the resolution passed by the Board of Directors, Trustee of a Trust coming along with the resolution passed by the Trust Board and Office Bearer of an organization coming along with the resolution passed by the executive committee will be entitled to attend the meeting of General Body (of Members) and shall have power of voting. No proxy will be allowed to participate in the meeting.
- (j) Meeting can be convened online/offline mode.

(5) Powers and Function of the General Body (of Members):

Subject to the provisions of the Rules of the Institute, the General Body (of Members) shall act as a general deliberative and supervisory body and shall perform the following functions:

- (i) to review from time to time the broad policies and programmes of the Institute and to suggest measures for improvement and development of the Institute;
- (ii) to consider and approve resolutions with or without modification, if any, on the annual report, annual accounts, audit report on such accounts and the budget estimates of the Institute;
- (iii) to advise Kulapati in respect of any matter that may be referred to it for advice; and
- (iv) to perform such other function as may be considered expedient or thought fit in the interest of the Institute.

24. SELECTION COMMITTEE FOR APPOINTMENT OF TEACHING STAFF:

There shall be one or more Selection Committees constituted, for making recommendations to the Executive Council for appointment


to the post of Professors, Associate Professors, Assistant Professors and such other posts as may be prescribed, in accordance with the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018.

25. DISQUALIFICATION:

- (1) A person shall be disqualified for being chosen as, and for being, a member of any of the authorities, or being appointed as, and for being, an officer, of the institution deemed to be University if:
 - (i) if he or she is of unsound mind; or
 - (ii) if he or she is an un-discharged insolvent; or
 - (iii) if he or she has been convicted by a court of law for an offense involving moral turpitude and sentenced in respect thereof to imprisonment for not less than six months; or
 - (iv) if he or she has not been appointed as per the provisions of these regulations.
- (2) If any question arises as to whether a person is or had been subjected to any of the disqualifications mentioned above, the question shall be referred to the Chancellor, and his or her decision shall be final and no suit or other proceedings shall lie in any civil court against such decision.

26. MISCELLANEOUS MATTERS RELATING TO DIFFERENT AUTHORITIES:

- (1) If any question arises, as to whether any person, other than Government nominated or appointed, has been duly nominated or appointed as, or is, entitled to be a member of any authority or any committee of the institution deemed to be University, the matter shall be referred to the Chancellor, whose decision thereon shall be final and binding.
- (2) Any member, other than an ex-officio member of any authority, may resign by a letter addressed to the Registrar, and the resignation shall take effect as soon as it is accepted by the Chancellor or the Chairperson of the Executive Council, as the case may be.





- (1) The Vice-Chancellor shall be a whole-time salaried officer of the institution deemed to be University and shall be appointed by the Chancellor from a panel of three names suggested by a Search-cum-Selection Committee.
- (2) The qualifications of the Vice-Chancellor shall be in accordance with the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018.
- (3) The procedure for composition of Search-cum-Selection-Committee (SCSC) for the selection of Vice Chancellor shall be as under:
 - (i) a nominee of the Chancellor as the Chairperson of the Committee;
 - (ii) a nominee of the Chairman, University Grants Commission; and
 - (iii) an academician, with not less than ten years' service as Professor, nominated by the Executive Council.
 - (iv) A nominee of the Anushasta.
- (4) The Vice-Chancellor shall hold office for a term of five years from the date on which he or she enters upon his or her office or until he or she attains the age of seventy years, whichever is earlier and shall be eligible for re-appointment for one more term by following the procedure prescribed for the appointment of Vice-Chancellor:

Provided that notwithstanding the expiry of the said period of five years, he or she shall continue in office until his or her successor is appointed and enters upon his or her office, however, in no case, the Vice-Chancellor shall hold office beyond the age of seventy years.

Provided further that the Chancellor may direct the Vice-Chancellor, after his or her term has expired, to continue in office for such period, not exceeding a total period of one year.
- (5) If the office of the Vice-Chancellor becomes vacant due to death, resignation or otherwise, or if he or she is unable to perform his

or her duties due to ill health or any other cause, the Pro-Vice-Chancellor shall perform the duties of the Vice-Chancellor:

Provided that if the Pro-Vice-Chancellor is unavailable, the Chancellor shall appoint the senior most Professor or any other Professor who shall perform the duties of the Vice-Chancellor, until a new Vice-Chancellor assumes office or the existing Vice-Chancellor resumes the duties of his or her office, as the case may be.

30. POWERS AND DUTIES OF KULAPATI (VICE-CHANCELLOR):

- (1) The Vice-Chancellor shall be the Principal Executive Officer and academic officer of the institution deemed to be University and shall exercise general supervision and control over the affairs of the institution deemed to be University and give effect to the decision of all authorities of the institution deemed to be University.
- (2) The Vice-Chancellor may, if he or she is of the opinion that immediate action is necessary on any matter, exercise any power conferred on any authority of the institution deemed to be University by or under these regulations and shall report to such authority at its next meeting the action taken by him or her on such matter:

Provided that, if the authority mentioned in this sub-regulation is of the opinion that such action ought not to have been taken, it may refer the matter to the Chancellor whose decision thereon shall be final.

Provided further that any person in the service of the institution deemed to be University who is aggrieved by the action taken by the Vice-Chancellor under this regulation shall have the right to represent against such action to the Executive Council within ninety days from the date on which decision on such action is communicated to him and thereupon the Executive Council may confirm, modify or reverse the action taken by the Vice-Chancellor.

- (3) The Vice-Chancellor, if he or she is of the opinion that any decision of any authority of the institution deemed to be University is beyond the power of the authority conferred by the provisions of these regulations or that any decision taken is not in the interest of the institution deemed to be University, may

ask the authority concerned to review its decision within sixty days of such decision and if the authority refuses to review the decision either in whole or in part or no decision is taken by it within the said period of sixty days, the matter shall be referred to the Chancellor whose decision thereon shall be final.

- (4) The Vice-Chancellor shall be the ex-officio Chairperson of the Executive Council, the Academic Council and the Finance Committee and shall, in the absence of the Chancellor, preside at the Convocations held for conferring degrees to the students.
- (5) The Vice-Chancellor shall be entitled to be present at, and address, any meeting of any authority or other body of the institution deemed to be University, but shall not be entitled to vote unless he or she is a member of such authority or body.
- (6) It shall be the duty of the Vice-Chancellor to see that these regulations are duly observed and implemented and he or she shall have all the powers necessary to ensure such implementation.
- (7) The Vice-Chancellor shall have all the powers necessary for the proper maintenance of discipline in the institution deemed to be University, and he or she may delegate any such powers to such person or persons, as he or she may deem fit with the concurrence and approval or ratification of the Executive Council.
- (8) The Vice-Chancellor shall have the power to convene or cause to be convened the meetings of the Executive Council, the Academic Council, the Finance Committee, and other authorities.

31. REMOVAL OF KULAPATI (VICE-CHANCELLOR):

- (1) Where there are reasons to believe that the Vice-Chancellor of an institution deemed to be University does not possess the qualifications as required under the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018, or is not appointed as per the procedure stipulated in these regulations or has committed any financial or administrative impropriety, the Chairman of Commission shall constitute an enquiry committee consisting of

academic, administrative or financial experts to enquire into the matter.

- (2) On the directions from the Commission, the Chancellor shall place the Vice-Chancellor under suspension, pending an enquiry.
- (3) The enquiry committee shall give an opportunity of hearing to the Vice-Chancellor before submitting its report to the Commission and where the report of the enquiry committee confirms the ineligibility or procedural violations or impropriety, as the case may be, the Commission shall direct the Chancellor to remove the Vice-Chancellor by following due procedure:
- (4) Notwithstanding anything contained in these regulations, the Chancellor may, at any time after the Vice-Chancellor has entered upon his or her office, by order in writing, remove the Vice-Chancellor from office on the grounds of incapacity, misconduct or violation of these regulations:

Provided that the Chancellor shall make no such order unless the Vice-Chancellor has been given a reasonable opportunity of showing cause against the action proposed to be taken against him.


Provided further that the Chancellor may, at any time before making such order, place the Vice-Chancellor under suspension, pending an inquiry.

32. UPAKULAPATI (PRO VICE-CHANCELLOR):


- (1) On the recommendation of the Vice-Chancellor, the Executive Council may appoint a Professor as Pro-Vice-Chancellor to discharge the duties of the Pro-Vice-Chancellor in addition to his or her duties as a Professor:

Provided further that where the recommendation of the Vice-Chancellor is not accepted by the Executive Council, the matter shall be referred to the Chancellor, who may either appoint the Professor recommended by the Vice-Chancellor or ask the Vice-Chancellor to recommend name of another Professor for re-consideration by the Executive Council.

- (2) The term of office of the Pro-Vice-Chancellor shall be such as may be decided by the Executive Council, but it shall not, in any case,

exceed five years or until the expiration of the term of office of the Vice-Chancellor, whichever is earlier:

Provided that the Pro-Vice-Chancellor whose term of office has expired shall be eligible for re-appointment by following the procedure prescribed for the appointment of Pro-Vice-Chancellor:

Provided further that the Pro-Vice-Chancellor shall, while discharging the duties of the Vice-Chancellor, continue in office, notwithstanding the expiration of his or her term of office as Pro-Vice-Chancellor, until the Vice-Chancellor resumes office or a new Vice-Chancellor assumes office, as the case may be:

Provided also that, in any case, the Pro-Vice-Chancellor shall retire on attaining the age of sixty-five years.

- (3) The Pro-Vice-Chancellor shall have the powers and duties as may be prescribed by the rules of the institution deemed to be University.
- (4) The Pro-Vice-Chancellor shall assist the Vice-Chancellor in respect of such matters as may be specified by the Vice-Chancellor on this behalf, from time to time, and shall also exercise such powers and perform such duties as may be assigned or delegated to him by the Vice-Chancellor.

33. KULASACHIVA (REGISTRAR):

- (1) (a) The Registrar shall be a whole-time salaried officer of the institution deemed to be University and shall be appointed by the Executive Council on the recommendations of the selection committee consisting of the following:
 - a. Vice-Chancellor - Chairperson;
 - b. one nominee of the Chancellor;
 - c. two members of the Executive Council nominated by it; and
 - d. one expert not in the service of the University to be nominated by the Executive Council.
- (b) The meeting of the selection committee shall be fixed after prior consultation with, and subject to the convenience of the Chancellor's nominee and the experts nominated by the



Executive Council and the proceedings of the selection committee shall not be valid unless at least three of the Chancellor's nominees or persons nominated by the Executive Council attended the meeting.


- (2) The Registrar shall hold office for a term of five years from the date of assuming office and shall be eligible for re-appointment for a second term by following the procedure prescribed for Registrar:

Provided that, the Registrar shall retire on attaining the age of sixty years and the emoluments and other terms and conditions of service of the Registrar shall be such as may be prescribed by the rules of the institution deemed to be University.

- (3) When the office of the Registrar is vacant or when the Registrar is, by reason of illness, absence, or any other cause, unable to perform the duties of his or her office, the duties of the office shall be performed by such person as the Vice-Chancellor may appoint for the purpose.
- (4) The Registrar shall be ex-officio Secretary of the Executive Council and the Academic Council, but shall not be deemed to be a member of any of these authorities.
- (5) The Registrar shall be directly responsible to the Vice-Chancellor and work under his or her direction.
- (6) The Registrar shall have the power to take disciplinary action against employees, excluding teachers and other academic staff, as may be specified in the order of the Executive Council and to suspend them pending inquiry, to administer warnings to them or to impose on them the penalty of censure or the withholding of increment:
- Provided that no such penalty shall be imposed unless the person has been given a reasonable opportunity of showing cause against the action proposed to be taken in regard to him or her.
- (7) An appeal shall lie to the Vice-Chancellor against any order of the Registrar imposing any of the penalties specified in sub-regulation(6).

- (8) In the case where the inquiry discloses that a punishment beyond the power of the Registrar is called for, the Registrar shall, upon the conclusion of the inquiry, make a report to the Vice-Chancellor along with his or her recommendations:

Provided that an appeal shall lie to the Executive Council against an order of the Vice-Chancellor imposing any penalty.

- (9) It shall be the duty of the Registrar:

- (i) to be the custodian of the records, the common seal, and such other property of the institution deemed to be University as the Executive Council shall commit to his or her charge;
- (ii) to issue all notices convening meetings of the Executive Council, the Academic Council, and any Committees appointed by those authorities;
- (iii) to keep the minutes of all the meetings of the Executive Council, the Academic Council, and any Committees appointed by those authorities;
- (iv) to conduct the official correspondence between the Executive Council and the Academic Council;
- (v) to supply to the Chancellor copies of the agenda of the meetings of the authorities of the institution deemed to be University as soon as they are issued and the minutes of such meetings;
- (vi) to represent the institution deemed to be University in suits or proceedings by or against the University; sign powers of attorney and verify pleadings or depute his or her representative for the purpose;
- (vii) to perform such other duties as may be specified in the rules of the institution deemed to be University or as may be required from time to time by the Executive Council or the Vice-Chancellor, as the case may be;
- (viii) to enter into an agreement, sign documents, and authenticate records on behalf of the institution deemed to be University;

- (ix) to make arrangements to safeguard and maintain the buildings, gardens, office, canteen, cars and other vehicles, laboratories, libraries, reading rooms, equipment and other properties of the institution deemed to be University; and
- (x) to conduct the official correspondence on behalf of the authorities of the institution deemed to be University.

34. VITTADHIKARI (FINANCE OFFICER):

- (1) The Finance Officer shall be appointed by the Executive Council on the recommendations of a selection committee constituted for the purpose and he or she shall be a whole-time salaried officer of the institution deemed to be University.
- (2) The Finance Officer shall be appointed for a term of five years and shall be eligible for re-appointment by following the procedure prescribed for the appointment of the Finance Officer: Provided that, the Finance Officer shall retire on attaining the age of sixty years.
- (3) The emoluments and other terms and conditions of service of the Finance Officer shall be such as may be prescribed by the Executive Council from time to time.
- (4) When the office of the Finance Officer is vacant or when the Finance Officer is, by reason of illness, absence or any other cause, unable to perform the duties of his or her office, the duties of the office shall be performed by such person as the Vice-Chancellor may appoint for the purpose.
- (5) The Finance Officer shall be ex-officio Secretary of the Finance Committee but shall not be deemed to be a member of such Committee.
- (6) The Finance Officer shall:
 - (i) exercise general supervision over the funds of the institution deemed to be University and shall advise it as regards its financial policy; and
 - (ii) perform such other financial functions as may be assigned to him by the Executive Council or as may be prescribed by the rules of the institution deemed to be University.

(7) Subject to the control of the Executive Council, the Finance Officer shall:

- (i) ensure that the limits fixed by the Executive Council for recurring and non-recurring expenditures for a year are not exceeded and that all amounts of money are expended on the purpose for which they are granted or allotted;
- (ii) be responsible for the preparation of annual accounts and the budget of the institution deemed to be university and for their presentation to the Executive Council;
- (iii) keep a constant watch on the state of the cash and bank balances and on the state of investments;
- (iv) watch the progress of the collection of revenue and advice on the methods of collection employed;
- (v) ensure that the registers of buildings, land, furniture, and equipment are maintained and up-to-date and that stock-checking is conducted, of equipment and other consumable materials in all offices, departments, schools, faculties, centers and specialized laboratories;
- (vi) bring to the notice of the Vice-Chancellor un-authorized expenditure and other financial irregularities and suggest disciplinary action against persons at fault;
- (vii) call for from any office, department, school, faculty, centre, laboratory, etc. maintained by the institution deemed to be University any information or returns that he or she may consider necessary for the performance of his or her duties; and
- (viii) work under the direction of the Vice-Chancellor and shall be responsible to the Executive Council through the Vice-Chancellor.

35. CONTROLLER OF EXAMINATIONS:

- (1) The Controller of Examinations shall be appointed by the Executive Council on the recommendations of a selection committee constituted for the purpose and he or she shall be a whole-time salaried officer of the institution deemed to be University.

- (2) The Controller of Examinations shall be appointed for a term of five years and shall be eligible for reappointment by following the procedure prescribed for the appointment of Controller of Examination:


Provided that the Controller of Examinations shall retire on attaining the age of sixty years.

- (3) The emoluments and other terms and conditions of service of the Controller of Examination shall be such as may be prescribed by the Executive Council from time to time.
- (4) When the office of the Controller of Examinations is vacant or when the Controller of Examinations is, by reason of illness, absence or any other cause, unable to perform the duties of his or her office, the duties of the office shall be performed by such person as the Vice-Chancellor may appoint for the purpose.
- (5) The Controller of Examination shall arrange for and superintend the examinations of the institution deemed to be University in the manner as may be prescribed by the rules of the institution deemed to be University.
- (6) The Controller of Examinations shall be a permanent invitee to the Academic Council.
- (7) The Controller of Examinations shall ensure that all the specific directions of the Executive Council, Academic Council and Vice-Chancellor in respect of examination and evaluation are complied with.

36. DEAN:

- (1) The Departments dealing with allied subjects may be grouped into faculties or schools, etc., and every faculty shall be headed by a Dean.
- (2) Every Dean of the school or faculty shall be appointed by the Vice-Chancellor from amongst the Professors in the school or faculty, by rotation, for a period of two years:

Provided that if there is only one Professor or no Professor in a school or faculty, the Dean shall be appointed, for the time being, from amongst the Professor, if any, and the Associate Professors in the school or faculty.

- (3) When the office of the Dean is vacant or when the Dean is, by reason of illness, absence or any other cause, unable to perform duties of his or her office, the duties of the office shall be performed by the senior-most Professor or Associate Professor, as the case may be, in the School.
- (4) The Dean shall be the Head of the school or faculty or centre and shall be responsible for the conduct and maintenance of the standards of teaching and research in the school or faculty or centre and shall have such other functions as may be prescribed by the rules of the institution deemed to be University.
- (5) The Dean shall have the right to present and speak at any meeting of the Board of Studies or Committees of the school or faculty or centre, as the case may be, but shall not have the right to vote there unless he is a member thereof.

37. HEAD OF THE DEPARTMENT:

- (1) There shall be a Head of the Department or chairperson of the centre for each of the department or centre in the institution deemed to be University, who shall be appointed by the Vice-Chancellor from amongst the Professors of the department or centre:

Provided that if there is no Professor in the department or centre or there is only one Professor in the department or centre, whose term as Head of the department or chairperson of the centre is ending, the Vice-Chancellor may appoint an Associate Professor as Head of the Department.

- (2) The term of the Head of the department or chairperson of the centre shall normally be two years and he or she shall be eligible for re-appointment for one more term by following the procedure prescribed for appointment of the Head of the department or chairperson of the centre.
- (3) The powers and functions of the Head of the department or chairperson of the centre shall be prescribed by the rules of the institution deemed to be University.

38. PROCEDURE FOR HOLDING MEETINGS:

An appropriate notice of not less than 7 days of the meeting of any authority of the Institution shall be given. Emergency meetings may

be convened at a shorter notice, for reasons to be recorded in writing for such emergency meeting, and any business, which may be urgent in nature, may be carried out by circulation amongst its members. In case, the meeting has to be adjourned for want of quorum, it shall be held on the same day at same place after lapse of 30 minutes but no other matter except what is stated in the notice shall be discussed.

39. ACTING CHAIRMAN OF THE MEETING:

Where no provision is made for a Chairman to preside over a meeting of an authority of the Institution, or any committee of such authority, or if the Chairman so provided is absent, the members present may select one from amongst themselves to preside at such meeting.

40. VALIDATION OF CERTAIN ACTIONS, DECISIONS:

No action or proceedings of any authority or anybody or any committee of the Institution shall be invalid merely by reason of any vacancy therein.

41. ADMISSION AND FEE STRUCTURE:

(A) ADMISSION:

Admission of students to the institution shall be strictly based on merit in the entrance exam conducted by a Government Testing Agency or the institution deemed to be University and as prescribed by the appropriate statutory authority, wherever applicable and in case of no entrance examination, the admission of students to the institution deemed to be University may be made in the manner specified in the prospectus.

(B) FEE STRUCTURE:

- (1) Donation or capitation fee in whatever nomenclature or form, either directly or indirectly, is strictly prohibited.
- (2) The institutions deemed to be Universities shall follow the rules and regulations regarding fee structure, number of seats, etc., issued by the relevant statutory bodies and in case an institution deemed to be University offers different courses which come under the regulatory ambit of different statutory bodies, namely the University Grants Commission, the All India Council of Technical Education, National Medical Council etc., the rules and

regulations regarding fee structure, number of seats, etc., issued by such statutory body concerned shall be applicable.

- (3) The fee shall be fixed transparently, keeping in view non-profiteering or non-commercial aspects.
- (4) The fee shall be collected as declared in the prospectus of the institution deemed to be University and with a proper receipt for such payment and the prospectus shall also state that donation or capitation fee in whatever nomenclature or form, either directly or indirectly, shall not be collected from the student or parent and in case of any grievance, the student or parent may submit their complaint to the institution deemed to be University.
- (5) The institution deemed to be University may provide fee concession or scholarships or may allocate some seats to meritorious students belonging to socially and economically deprived groups of the society.
- (6) The institution deemed to be University shall abide by all the University Grant Commission notifications, guidelines regarding the refund of fees and return of original certificates, as may be issued from time to time.
- (7) Every institution deemed to be University shall maintain the records of the entire process of selection of candidates, exhibit such records on its website, and preserve such records for a minimum period of five years.
- (8) The institution deemed to be University shall make available the prospectus on its website at least sixty days before the commencement of admissions, including fee structure, refund policy, number of seats in a programme, eligibility qualifications, admission process, etc.
- (9) The institution deemed to be University shall not retain any original certificates of the students, faculty members, and staff.

42. INSTITUTION DEEMED TO BE UNIVERSITY OPEN TO ALL:

- (1) The institution deemed to be University shall be open to the persons of all genders and of whatever caste, creed, race or class, and it shall not be lawful for the institution deemed to be University to adopt or impose on any person, any test

whatsoever of religious belief or profession in order to entitle him or her to be appointed as a faculty member of the institution deemed to be University or to hold any other office therein or to be admitted as a student in the institution deemed to be University or to graduate there at or to enjoy or exercise any privilege thereof:

Provided that nothing in this section shall be deemed to prevent the institution deemed to be University from making special provision for the employment or admission of women, persons with disabilities, or of persons belonging to the weaker section of the society and, in particular, of the Scheduled Castes, the Scheduled Tribes and the other socially and educationally backward classes of citizens.

- (2) All policies and procedures, in matters of admission, fee, and employment as applicable to the university level public funded and self-financing institutions, respectively, shall apply.

43. INSTITUTION DEEMED TO BE UNIVERSITY TO BE UNITARY:

The institution deemed to be University shall be unitary in nature and shall not affiliate any other institution.

44. RESERVATION POLICY:


Institution deemed to be University shall implement the policy on reservations in admissions and recruitment, in accordance with the provisions of the Constitution of India and any Act of Parliament for the time being in force and disclose all such information on its website.

45. ONLINE OR DISTANCE EDUCATION:

Institutions deemed to be Universities may offer courses online or distance courses or degrees in accordance with the regulations notified by the Commission from time to time.

46. VIOLATION OF REGULATIONS:

- (1) Where the Government or the Commission, as the case may be, receives information by way of a complaint or otherwise, that an institution deemed to be University has violated any of the provisions of these regulations, it shall cause to conduct an

enquiry into the facts of such information after issuing a notice to the said effect to the institution deemed to be University.

- (2) The Commission may also cause an inspection, to be made by experts in matters of academics, administration, and finance regarding academic outcomes or any matter connected with the administration or finances of the institution deemed to be University for the purpose of the enquiry.
- (3) Based on the enquiry or through procedures mentioned in these regulations, if the Government or the Commission, as the case may be, is satisfied that the regulations have been violated, the institution deemed to be University shall be subjected to such action as provided in the University Grants Commission (Institutions deemed to be Universities) Regulations, 2023.
- (4) In the event of non-compliance of any of the provisions as enumerated herein above or any other provisions as stipulated in the University Grants Commission (Institutions deemed to be Universities) Regulations, 2023, the Institution shall be liable to be subjected to one or more of the following actions, namely:
 - (i) for violation of these regulations established by the enquiry committee set up by the Commission or Government, the institution deemed to be University shall be warned in writing with public notice or barred from any expansion in terms of diversification to new courses or programmes of study or departments and establishment of off-campus or off-shore campuses, for a period of three years or as recommended by the enquiry committee, whichever is higher;
 - (ii) continuous violation of regulations established by the enquiry committee set up by the Commission or the Government may result in closure of the courses or programmes of study or Departments and off campuses or constituent institutions or off-shore campuses or may result in withdrawal of the status of institution deemed to be University;
 - (iii) in order to protect the interests of students in case of surrender or withdrawal of the status, as the case may be, shall take effect only after the last batch of students on the

rolls of the institution deemed to be University or its constituent units, has been accorded opportunity to qualify for the completion of the programme of study and award of degree.

47. FUNDS, ACCOUNTS, AUDITS AND ANNUAL REPORT:

- (1) The books of accounts of the institution deemed to be University shall be maintained, managed, and operated in the name of the institution deemed to be University and not in the name of the sponsoring body or any other body; and, shall be kept in such form as may be specified by the Executive Council and conform to the rules or regulations, if any, prescribed by the Commission, in this regard.
- (2) Funds shall not be diverted at any time from the accounts of the institution deemed to be University to any other accounts, including to the accounts of the sponsoring body or to any other body.
- (3) The institution deemed to be University shall get its books of accounts audited annually, separately published and uploaded on the website of the institution and the accounts of institution deemed to be University shall also, where required, be open for inspection by the Commission.
- (4) The annual financial statements and accounts shall be audited by a qualified professional, a Member or Fellow of the Institute of Chartered Accountants of India, to be appointed by the institution deemed to be University:

PROVIDED that, the Commission may, on receipt of information regarding financial impropriety or embezzlement or illegal diversion of funds from the accounts of the institution deemed to be University; or of fees being collected against the provisions of these regulations, issue a notice directing the institution deemed to be University to show cause as to why an inspection, including a forensic audit, not be ordered in respect of the complaint, and after providing a reasonable opportunity to the respondent institution, the Commission may on being satisfied that there were sufficient grounds to proceed further, cause an inspection by a team of the Commission or may direct a forensic audit; the report of and the inspection team and the forensic audit report




taken together shall form the basis for the Commission to take further action, as it may be deemed fit, under these regulations including the recommendation for withdrawal of institution deemed to be University status, to the Government.

- (5) Annual Reports, Annual Financial Statements, and Audit Reports shall be uploaded on the institution deemed to be University website and also on the Commission's portal, after due approval by the Executive Council.


48. MISCELLANEOUS:


- (1) The institution deemed to be University shall, as soon as may be, after the completion of the academic programme, and in no case later than one hundred and eighty days from the date of such completion, ensure that the degree, diploma, certificate, or any other qualification in respect of the programme of studies, is awarded and made available to students.
- (2) The institutions deemed to be Universities shall compulsorily create Academic Bank of Credits (ABC), identities of their students and upload their credit scores in digital lockers and ensure that the credit scores are reflected in ABC portal and adopt Samarth e-Gov.
- (3) The institution deemed to be University shall not at any time enter into any franchise agreement or arrangement, either overtly or covertly, with any individual or organisation for establishing, maintaining, or operating the off-campus or off-shore campus or constituent units or course or programme of study or department or school or faculty of the institution deemed to be University except in the following cases, namely:
- (a) the institution deemed to be University, which is eligible under sub-regulations (1) and (2) of regulation 8 may enter into an agreement or arrangement, if—
- (i) the establishment, maintenance, or operation of such institution is permitted under any Act of Parliament or the rules or regulations made there under; and
- (ii) it has made an application under sub-regulation (3) of regulation 8, after following the procedure specified in these regulations

- (b) the campus to be established under such agreement or arrangement shall be:
- (i) treated as an off-campus centre of the institution deemed to be University as long as such agreement or arrangement remains valid under such law; and
 - (ii) subject to similar standards of audit and disclosure as a not-for-profit entity as that of the institution deemed to be University;
- (c) the institution deemed to be University, which is eligible under regulation 8 may enter into an agreement or arrangement for practical training of students of a skill-oriented vocational courses, if such course is approved by the University Grants Commission or any other body established under any Act of Parliament.
- (d) twinning Programmes, Joint Degree Programmes, and Dual Degree Programmes shall be offered in accordance with the provisions stipulated in the University Grants Commission (Academic Collaboration between Indian and Foreign Higher Educational Institutions to offer Twinning, Joint Degree, and Dual Degree Programmes) Regulations, 2022.
- (e) the income and property of the institution deemed to be University shall be utilised solely for promoting the objectives of the institution deemed to be University.
- (f) the Commission shall have the power to issue directions to an institution deemed to be University for implementation of any public policy of the Government or in respect of any law in force, including appropriate directions in case of any violation of any law or policy by the institution deemed to be University.
- (g) no portion of the income and property of the institution deemed to be University shall be paid or transferred directly or indirectly, by way of dividend, bonus, or otherwise how so ever by way of profit to the persons who were at any time or are members of the institution deemed to be University or to any of them or any persons claiming through them:

PROVIDED that nothing herein contained shall prevent the payment in good faith of remuneration to any member thereof or another person as consideration for any service rendered to the institution deemed to be University or for traveling or other allowances and such other charges.

- (h) in consultation with the Commission, the Government shall have the power to impose such other conditions, not inconsistent with these regulations, in the notification, and the same shall be binding on the institution deemed to be University.
- (i) where the institution deemed to be University wishes to surrender its status of "institution deemed to be University", it shall do so with the prior permission of the Government; and similarly, withdrawal of any constituent units or off-campus or off-shore campus of the institution deemed to be University from the purview of an institution deemed to be University, shall require the sponsoring body to take the prior permission of the Government:

PROVIDED that such surrender or withdrawal, as the case may be, shall take effect only after the last batch of students on the rolls of the institution deemed to be University or its constituent units, as the case may be, have been accorded the opportunity to qualify for the completion of the programme of study and award of degree.

- (j) the institution deemed to be University shall furnish to the Central Government or the Commission such returns or other information with respect to its property or activities as the Central Government or the Commission may, from time to time, require, within such period as may be specified by the Central Government or Commission.
- (k) convocations of the institution deemed to be University for conferring the degrees or for other purposes shall be held in such manner as may be prescribed by the rules of the institution deemed to be University.
- (l) the Executive Council may, by a resolution passed by a majority of not less than two-thirds of the members present

and voting, withdraw a degree of academic distinction conferred on, or any certificate or diploma granted to, any person by the institution deemed to be University for good and sufficient cause:

PROVIDED that no such resolution shall be passed until a notice in writing has been given to that person calling upon him or her to show cause within such time as may be specified in the notice as to why such a resolution shall not be passed and until his or her objections, if any, and any evidence he or she may produce in support of them, have been considered by the Executive Council.


- (m) in the event of conflict of opinion with regard to the interpretation of these regulations, the opinion of the Commission shall be final.
- (n) the provisions contained in the University Grants Commission (Institutions deemed to be Universities) Regulations, 2023 shall prevail in case of any inconsistency or conflicting provisions in any other regulations issued by the Commission under the provisions of the Act.

49. ALTERATION, AMENDMENTS AND ADDITIONS TO THE RULES GOVERNING THE FUNCTIONING OF THE INSTITUTION DEEMED TO BE UNIVERSITY:

No Rule and Bye-law governing the functioning of the Institution may be altered, amended and added to by the Executive Council or such other competent body to the effect that it is not in conflict with or to the detriment of the provisions of these Regulations; and such, alteration, amendment or addition to the Rules and Bye-laws shall not be given effect to without the prior approval of the Commission in accordance with the provision of the Societies Registration Act, 1860 and Section 6 of the Rajasthan Societies Registration Act, 1958 or the relevant Public Trust Act as in force for the time being.

50. ADJUSTMENT OF INCOME AND PROPERTY ON DISSOLUTION OF THE INSTITUTION:

If on the winding up or dissolution of the Institution there remains, after the satisfaction of all its debts and liabilities, any property whatsoever, the same shall not be paid or distributed among the members of the

Institution or any of them, but shall be transferred to Sponsoring Society or the Commission or other bodies in consultation with the agencies concerned who have helped in creation of those assets.


51. LEGAL PROCEEDINGS:



- (2) No suit or legal proceedings shall lie against the Government or the Commission in respect of anything done or purported or intended to be done in pursuance of any of these regulations.
