WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in superfession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the institution i.e. Jain Vishwa Bharti Institute, Ladnun, Nagaur-341306, Rajasthan has been recognized for B.Ed. course by NRC vide order No. F.NRC/NCTE/RJ-1387/62601-607 dt 17.09.2008 for an intake of 200.
- AND WHEREAS, the institution Jain Vishwa Blarti Institute, Ladnun, Nagaur-341306, Rajasthan has by affidavit consented to come under New Regulations and sought for four basic units in B.Ed. which require additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have four basic units of 50 students each subject to the institution fulfilling following conditions namely,
